PROPOSED ORDINANCE

AN ORDINANCE ESTABLISHING A NOVALICHES MEGA TRANSPORT TERMINAL IN NOVALICHES, QUEZON CITY AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE.

WHEREAS, the Quezon City Government recognizes the need for a centralized transport terminal in Novaliches, Quezon City in order to provide a safe, efficient, and organized public transportation system for the benefit of its residents in Novaliches area and the general public;

WHEREAS, the establishment of a mega transport terminal in Novaliches will help decongest traffic congestion in Novaliches, reduce pollution, and promote economic growth in Novaliches;

WHEREAS, the Quezon City Government has the power to establish and operate public utilities, including public transport terminals, for the general welfare of its constituents:

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

Section 1. Establishment of the Novaliches Mega Transport Terminal. - There is hereby established a Novaliches Mega Transport Terminal in Novaliches, Quezon City, which shall serve as a centralized terminal for public utility vehicles, buses, modern jeepneys and other modes of public transportations in Novaliches, Quezon City.

Section 2. Location and Design. - The Novaliches Mega Transport Terminal shall be located on an appropriate parcel of land owned by the Quezon City Government in Novaliches, or in an appropriate area to be acquired for the purpose. The terminal shall be designed to accommodate buses, modern jeepneys and other form of public utility vehicles. The terminal shall have adequate facilities for passengers, including waiting areas, restrooms, and food and beverage stalls.

Section 3. Appropriation of Funds. - The Quezon City Government hereby appropriates the sum of Fifty Million Pesos (Php50,000,000.00) from its General Fund to cover the costs of the establishment of the Novaliches Mega Transport Terminal.

Section 4. Management and Operation. - The Novaliches Mega Transport Terminal shall be managed and operated by the Quezon City Government through the Department of Public Order and Safety (DPOS), in coordination with the Land Transportation Franchising and Regulatory Board (LTFRB), the Land Transportation Office (LTO) and other relevant national and city government agencies.

Section 5. Implementing Rules and Regulations. - The Quezon City Government shall promulgate the necessary rules and regulations for the proper implementation of this ordinance, including the setting of terminal fees, the regulation of public utility vehicles, and the maintenance of cleanliness and peace and order within the terminal.

Section 6. Effectivity. - This ordinance shall take effect upon its approval.
