PROPOSED RESOLUTION NO. _____, S-2026

A RESOLUTION RATIFYING THE RECONSTITUTION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE QUEZON CITY GOVERNMENT AND DEFINING ITS FUNCTIONS PURSUAN TO THE 2025 OMNIBUS RULES ON APPOINTMENTS AND OTHER HUMAN RESOURCES ACTIONS.

WHEREAS, Pursuant to section 80 (b) of the local Government Code of 1991, a Personnel Selection Board Shall be established in every province, city or municipality to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion of such policies as would contribute to employee's welfare;

WHEREAS, the city government adheres to the principle that the appointments in the civil service shall be made only according to the merit and fitness pursuant to section 12, Rule VI of the Omnibus Rules Implementing Book V of the Administrative Code of 1987, requiring a system of merit promotion in the selection and promotion of employees and officials;

WHEREAS, in order to effectively implement the rules under CSC Resolution No. 2500358 or the 2025 Omnibus Rules on Appointments and other Human Resources Actions, there is hereby a need to reconstitute the existing HRMPSB which is responsible for the adoption of a formal screening procedure and formulation of criteria for evaluation of candidates credentials for selection and promotion.

WHEREAS, Executive order No. 29, Series 2022, reconstituted the HRMPSB for the Executive and Legislative branches of the Quezon City Government.

WHEREAS, in support of Executive Order No. 29, Series of 2022, officials and employees were formally designated as member of the HRMPSB by virtue of Office Order No. 184, Series of 2025.

NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, Executive Order No. 29, series of 2022 and Office Order No. 184, Series of 2025, reconstituting the Human Resource Merit Promotion and Selection Board (HRMPSB) of the Quezon City Government.

RESOLVED, FURTHER, that the reconstituted HRMPSB shall serve as the body tasked to assist the Appointing Authority in the judicious and objective selection of candidates for appointment and promotion to first and second level positions including executive and managerial positions in the Executive and Legislative branches of the Quezon City Government, in accordance with the 2025 Omnibus Rules on Appointments and other Human Resources Actions.
