AN ORDINANCE AMENDING QUEZON CITY ORDINANCE NO. SP-3194, S-2023, ENTITLED "AN ORDINANCE GIVING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, THE GENERAL AUTHORITY TO SIGN ALL MEMORANDA OF AGREEMENT OR UNDERSTANDING AND SIMILAR AGREEMENTS THAT DO NOT INVOLVE ANY SALE, PURCHASE OR DISPOSAL OF GOVERNMENT PROPERTIES NOR INVOLVE ANY DISBURSEMENT OF PUBLIC FUNDS NOR BIND THE QUEZON CITY GOVERNMENT INTO ANY MONETARY OBLIGATION"

*WHEREAS, the Quezon City Government enacted Quezon City Ordinance No. SP-3194, S-2023, entitled "An Ordinance Giving the City Mayor, Honorable Ma. Josefina G. Belmonte, the General Authority to Sign All Memoranda of Agreement or Understanding and Similar Agreements that do not Involve Any Sale, Purchase or Disposal of Government Properties nor Involve Any Disbursement of Public Funds nor Bind the Quezon City Government into Any Monetary Obligation";*

WHEREAS, there is a necessity to extend the general authority to the City Mayor, Honorable Ma. Josefina G. Belmonte, granted under the said Ordinance, to her duly authorized representative, for purposes of optimizing operational procedures of the Quezon City Government and enhancing the delivery of public services with greater responsiveness and efficiency.

NOW, THEREFORE,

BE IT ENACTED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 1 of Quezon City Ordinance No. SP-3194, S-2023 is hereby amended to read as follows:

“SECTION 1. GENERAL AUTHORITY. – The City Mayor, Honorable Ma. Josefina G. Belmonte, or her duly authorized representative, is hereby authorized to sign all memoranda of agreement or understanding and all similar agreements or instruments, provided that they: do not involve the sale, purchase, or disposal of government properties; do not involve the disbursement of public funds; and do not bind the Quezon City Government into any monetary obligations.”

SECTION 2. REPEALING CLAUSE. – The provisions of the Quezon City Ordinance No. SP-3194, S-2023 is hereby repealed or modified accordingly insofar as their provisions are inconsistent with this Ordinance. Likewise, all ordinances, issuances, executive orders, rules and regulations, or parts thereof which are inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. SUNSET PROVISION. – This Ordinance shall take effect in accordance with the provisions of the next succeeding section and shall continue to do so while the City Mayor, Honorable Ma. Josefina G. Belmonte remains in office. It shall be automatically revoked upon the change of leadership in the Office of the City Mayor.

*SECTION 4. EFFECTIVITY CLAUSE. – This Ordinance shall take effect ten (10) days after its posting in at least three (3) conspicuous places in Quezon City, including the bulletin board at the entrance of the Quezon City Hall.*
