AN ORDINANCE APPROVING THE ANNUAL BUDGET OF THE QUEZON CITY GOVERNMENT FOR THE CALENDAR YEAR 2026 IN THE AMOUNT OF FORTY-THREE BILLION THREE HUNDRED MILLION PESOS (PHP43,300,000,000.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE CITY GOVERNMENT AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE



WHEREAS, on October 14, 2025, the Local Chief Executive submitted to the Sangguniang Panlungsod, through the Office of the Secretary to the Sangguniang Panlungsod, the proposed budget of the City for the Calendar Year 2026;

WHEREAS, Section 319 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that on or before the end of the current fiscal year, the sanggunian concerned shall, enact through an ordinance the annual budget of the local government unit for the ensuing fiscal year on the basis of the estimates of income and expenditures;

WHEREAS, there is an urgent need to pass this Ordinance to support the financial needs and expenditures of the Quezon City Government for the Fiscal Year 2026.

NOW, THEREFORE,

BE IT ENACTED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Annual Budget of the Quezon City Government for the Calendar Year 2026 is hereby approved in the amount of Forty-Three Billion Three Hundred Million Pesos (Php43,300,000,000.00) covering the various expenditures for the operation of the Quezon City Government.

The budget documents consisting of the following are incorporated herein and made an integral part of this Ordinance:

- a. Budget Message of the City Mayor, Honorable Ma. Josefina G. Belmonte;
- b. Statement of Expenditures and Sources of Financing;
- c. Statement of Indebtedness;
- d. Statement of Statutory and Contractual Obligations and Budgetary Requirements;
- e. Statement of Fund Allocation by Sector;
- f. Personnel Schedule; and
- g. General Provisions.

SECTION 2. Forty-Three Billion Three Hundred Million Pesos (Php43,300,000,000.00), so much thereof, is hereby appropriated from the General Fund as may be necessary to be taken from the Estimate of Revenue certified as available by the City Treasurer as contained in the budget documents.

SECTION 3. SEPARABILITY CLAUSE. – If, for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, all other provisions hereof which are not affected thereby shall continue to be in full force and effect.






SECTION 4. EFFECTIVITY CLAUSE. – This Ordinance shall take effect immediately upon its approval.
