ORDINANCE NO. SP- **3487**, S-2026

AN ORDINANCE DESIGNATING A ONE-WAY TRAFFIC AND ONE-SIDE PARKING SCHEME ON SELECTED STREETS WITHIN BARANGAY MILAGROSA, DISTRICT III, QUEZON CITY AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Barangay Milagrosa passed Resolution Number 133, S-2024, urging the Quezon City Council to enact an Ordinance creating the Barangay Milagrosa one-way traffic and one-side parking scheme for its inner roads, purposely to bring order, method, and uniformity, for smooth traffic flow and public street parking and for other purposes;

WHEREAS, designating a one-way traffic and one-side parking scheme will decongest vehicular traffic, avoiding unnecessary delays and loss of previous time and resources;

WHEREAS, Section 458(a)(5)(vi) of the Local Government Code of 1991 provides that the Sangguniang Panlungsod has the power to "Regulate traffic on all streets and bridges; prohibit encroachments or obstacles thereon, and when necessary in the interest of public welfare, authorize the removal or encroachments and illegal constructions in public places."

NOW, THEREFORE,

BE IT ENACTED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. – An Ordinance Designating a One-Way Traffic and One-Side Parking Scheme on selected streets within Barangay Milagrosa, District III, Quezon City, and Providing Penalties for Violations Thereof.

SECTION 2. COVERAGE. – The following streets shall observe One-Way Traffic:

- a. Reverend Garcia Street corner going to Tirona Street (Delos Reyes Street side);
- b. Legaspi Street corner P. Tuazon Boulevard going to corner J. Ocampo Street;
- c. J. Ocampo Street corner Rajah Matanda Street going to corner Delos Reyes Street;
- d. Poblete Extension corner Poblete Interior going to Mascardo Street;
- e. Belarmino Street corner Mascardo Street going to F. Salalilla Street;
- f. F. Salalilla Street corner Kalantiaw Street going to Poblete Main;
- g. M. Gregorio corner Lakandula Street going to F. Salalilla Street;
- h. Alimudin Street corner Rajah Matanda Street going to Mascardo Street; and
- i. Poblete Main corner Poblete Interior going to P. Tuazon Boulevard.



One-Side Parking shall be likewise implemented on the following streets:

a. Pasaje Dela Paz Street corner P. Tuazon Boulevard going to J.P. Rizal Street	Right side parking
b. Tom Castro Street	No parking at all times
c. Lakandula Street corner P. Tuazon Boulevard to Lakandula Street	Left side parking
d. Tirona Street corner P. Tuazon Boulevard going to Delos Reyes Street	Left side parking
e. Reverend Garcia Street corner Tirona Street (P. Tuazon Boulevard side) going to Tirona Street (Delos Reyes Street side)	Right side parking
f. Sunrisers Street	No parking at all times
g. Delos Reyes Street corner J.P. Rizal Street to Dead End	Right side parking
h. Legaspi Street corner P. Tuazon Boulevard to J. Ocampo Street	Left side parking
i. J. Ocampo Street corner Rajah Matanda Street to Delos Reyes Street	Right side parking
j. Reverend Garcia Street corner Legaspi Street Interior	No parking at all times
k. Alvarez Street corner Rajah Matanda Street to Legaspi Street	Right side parking
l. Poblete Main corner Poblete Interior to P. Tuazon Boulevard	Right side parking
m. Poblete Interior corner Poblete Main to Belarmino Street	No parking at all times
n. Poblete Extension	No parking at all times
o. Poblete Interior corner Legaspi Street to Poblete Extension	Left side parking
p. Mascardo Street corner Rajah Matanda Street to Mascardo Street	Right side parking
q. Mascardo Street corner Alvarez Street to Oval Street	Right side parking
r. Alimudin Street	No parking at all times
s. Belarmino Street corner Mascardo Street to F. Salalilla Street	Right side parking
t. F. Salalilla Street corner Kalantiaw Street to Lakandula Street	Left side parking
u. F. Salalilla Street corner Lakandula Street to Poblete Main	No parking at all times
v. M. Gregorio Street corner Lakandula Street to F. Salalilla Street	Left side parking

SECTION 3. SIGNS. – The Traffic and Transport Management Department (TTMD) and the Sangguniang Barangay are hereby directed to appropriate funds for and to install the necessary traffic signs and announcements to inform all motorists and the general public of the existence and implementation of this Ordinance.

SECTION 4. DEPUTIZATION. – The Sangguniang Barangay shall arrange for qualified personnel, including, but not limited to, the Barangay Public Safety Officers (BPSOs), to undergo training, and the deputization by the TTMD of Quezon City, to enforce the provisions of this Ordinance.

SECTION 5. ENFORCEMENT. – The TTMD, with the assistance of the Barangay Deputized Traffic Enforcers and members of the Sangguniang Barangay, is hereby authorized and empowered to administer and implement all rules and regulations relative to this Barangay Milagrosa Traffic Management Ordinance. All existing Quezon City ordinances related to traffic management are hereby adopted.

SECTION 6. PENALTIES. – Violation of any provision of this Ordinance shall be penalized with a fine of One Thousand Pesos (Php1,000.00), if the vehicle is attended by the driver; or Two Thousand Pesos (Php2,000.00) and impoundment of the vehicle if unattended in accordance with Section 11(h) of Quezon City Ordinance No. SP-3172, S-2023, otherwise known as the Quezon City Traffic Code of 2023.

SECTION 7. IMPLEMENTING RULES. – The TTMD shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 8. REPEALING CLAUSE. – All ordinances, resolutions, executive orders, memorandum circulars, and administrative orders or parts thereof which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. – If any provision of this Ordinance is declared void or unconstitutional, the remaining portions shall not be affected and shall remain in full force and effect.

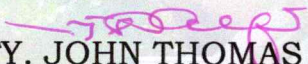
