A RESOLUTION RENEWING THE SPECIAL PERMIT OF JACBINGO CORP. TO OPERATE AN ELECTRONIC BINGO AT JACKMAN PLAZA, E. DELOS SANTOS AVENUE, BARANGAY RAMON MAGSAYSAY, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Jacbingo Corp., a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Antonio G. Teng, is applying for the renewal of a Special Permit to operate a Bingo Center/Hall at Jackman Plaza, E. Delos Santos Avenue, Barangay Ramon Magsaysay, District I, Quezon City;

WHEREAS, there is a need to renew the same Special Permit to enable the applicant to continue its business operations;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City ordinances, authorizes the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Jacbingo Corp. to operate an Electronic Bingo at Jackman Plaza, E. Delos Santos Avenue, Barangay Ramon Magsaysay, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo at Jackman Plaza, E. Delos Santos Avenue, Barangay Ramon Magsaysay, District I, Quezon City granted herein shall be subject to the following conditions:

- 1. the holding of Electronic Bingo shall be in accordance with the rules promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR);*
- 2. the operation of an Electronic Bingo shall not include the playing of games not related to or other than Electronic Bingo; and*
- 3. the operator is enjoined to prohibit from playing the abovementioned games individuals below 21 years of age.*


