WHEREAS, the Philippine National Police (PNP) plays a vital role in safeguarding public safety, maintaining peace and order, and upholding the rule of law across the Nation;

WHEREAS, President Ferdinand R. Marcos, Jr. has appointed Police Major General Nicolas D. Torre III as the new Chief of the Philippine National Police, in recognition of his outstanding leadership, extensive service record, and unyielding dedication to public service;

WHEREAS, Police Major General Nicolas D. Torre III, a native of Jolo, Sulu and a graduate of the Philippine National Police Academy (PNPA) Class of 1993, has served the Nation with distinction in various capacities, including as Provincial Director of Samar, deputy Regional Director for Operations of the NCRPO, and Director of the PNP Communications and Electronic Service;

WHEREAS, during his tenure as Director of the Quezon City Police District (QCPD) from August 2022 to August 2023, General Torre III introduced a three-minute police response program, enhance police visibility and responsiveness and strengthened community-oriented policing in the City;

WHEREAS, Police Major General Nicolas D. Torre III continued to exhibit exemplary leadership at the national level, particularly as Regional Director of Police Regional Office XI (Davao Region), where he led the lawful apprehension of high-profile personalities, and later as Director of the Criminal Investigation and Detection Group (CIDG), where he implemented law enforcement actions pursuant to both domestic and international legal mandates;

WHEREAS, the appointment of Police Major General Nicolas D. Torre III as PNP Chief is a reflection of his outstanding service record, integrity, professionalism and commitment to justice and the rule of law;

WHEREAS, the Quezon City Government proudly recognizes that the exemplary public service, discipline and dedication of Police Major General Nicolas D. Torre III serve as an inspiration and model for all Quezon City residents, especially the youth and civil servants, to emulate in their pursuit of excellence and service to the Nation.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express, the sincerest congratulations and commendation of the Quezon City Government, through the City Mayor, Honorable Ma. Sotto, and the Honorable Members of the 22<sup>nd</sup> Quezon City Council to former Quezon City Police District (QCPD) Director, Police Major General Nicolas D.
