WHEREAS, the 22nd Sangguniang Panlungsod of Quezon City previously adopted its Internal Rules of Procedure through Resolution No. SP-8999, S-2022, which was subsequently amended by Resolution Nos. SP-9000, S-2022, SP-9529, S-2023, SP-9641, S-2024 and SP-9964, S-2025;

WHEREAS, Section 50 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that the Sanggunian shall adopt its internal rules of procedure on the first day of its regular session, following the election of its members and within ninety (90) days thereafter;

WHEREAS, the Members of the 23rd Sangguniang Panlungsod of Quezon City, elected during the May 9, 2025 Local Elections, formally assumed office on June 30, 2025;
