RESOLUTION NO. SP- **10181**, S-2025

**A RESOLUTION DECLARING A STATE OF CALAMITY IN QUEZON CITY DUE TO THE EFFECTS OF SEVERE TROPICAL STORM WIPHA (CRISING) AND THE ENHANCED SOUTHWEST MONSOON (HABAGAT), AUTHORIZING THE UTILIZATION OF AVAILABLE CITY AND BARANGAY CALAMITY FUNDS, AND FOR OTHER PURPOSES**

*WHEREAS, Quezon City has been severely affected by the onslaught of Severe Tropical Storm Wipha (local name: Crising), compounded by the enhanced southwest monsoon (Habagat), resulting in widespread flooding, destruction of property, mass evacuation of residents, loss of livelihood, and disruption of essential services;*

*WHEREAS, initial damage assessments conducted by the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO), in coordination with various barangays, confirm the extensive impact of the calamity and the urgent need for large-scale relief, response, and rehabilitation efforts;*

*WHEREAS, pursuant to Section 16 (General Welfare Clause) and Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Government is empowered to adopt measures for the protection and general welfare of its constituents;*

*WHEREAS, Section 16 of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010," provided that the declaration and lifting of the State of Calamity may be issued by the local sanggunian, upon the recommendation of the Local Disaster Risk Reduction and Management Council, based on the results of the damage assessment and needs analysis;*

*WHEREAS, based on the latest consolidated reports from the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) as of July 22, 2025, 1:00 PM, a total of 7,790 families or 27,095 individuals across 51 barangays have been affected by Severe Tropical Storm Wipha (Crising), with the numbers continuing to increase as search and rescue, validation and damage assessment operations are still ongoing;*

*WHEREAS, multiple barangays have been placed under preemptive and forced evacuation due to rising floodwaters, with evacuation centers at full capacity and continuous relief operations being conducted;*

*WHEREAS, QCDRRMC approved Resolution No. 7, 2025 recommending to the Quezon City Council the declaration of a State of Calamity in Quezon City due to Severe Tropical Storm Crising;*

*WHEREAS, the declaration of a State of Calamity would facilitate the effective mobilization of resources, access to calamity funds, control prices of basic commodities, and implementation of emergency and recovery measures.*

*NOW, THEREFORE,*

*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to declare, as it does hereby declare, a State of Calamity in Quezon City due to the effects of Severe Tropical Storm Wipha (Crising) and the Enhanced Southwest Monsoon (Habagat), authorizing the utilization of available City and Barangay Calamity Funds, and for other purposes.*

*RESOLVED FURTHER, that the Quezon City Government, through the Office of the City Mayor, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), and other concerned departments and barangays, is hereby authorized to utilize all available City and Barangay Calamity Funds to implement immediate relief, rescue, and recovery operations, including the provision of food, water, medical and psychological assistance, temporary shelter, learning spaces, and the repair and rehabilitation of damaged infrastructure and public facilities.*

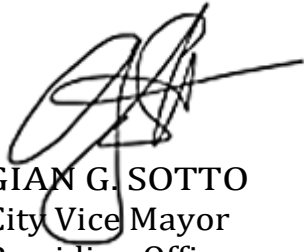
