**A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE AND/OR TRANSFER WITHOUT COST THREE (3) UNITS OF ISUZU GIGA FIRE TRUCKS TO THE QUEZON CITY FIRE DISTRICT AND TO TURN OVER DOCUMENTS PERTINENT TO THEIR OWNERSHIP**

*WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned;*

*WHEREAS, under Section 51(b) of the Administrative Code of 1987, the City Mayor, as the Local Chief Executive, is authorized to enter into contracts;*

WHEREAS, pursuant to Section 17 of the Local Government Code of 1991, local government units are mandated to exercise such powers and discharge such functions as may be necessary, appropriate, or incidental to the efficient and effective delivery of basic services and facilities, including public safety and emergency services;

WHEREAS, the Quezon City Government is the registered owner of the following motor vehicles, described as follows:

WHEREAS, these fire trucks are indispensable to the Quezon City Fire District in carrying out its core mandate of safeguarding lives and properties, responding to fire incidents, conducting rescue operations, and providing timely emergency assistance to the citizens of Quezon City;

WHEREAS, the City Government, through the Honorable City Mayor, intends to donate the aforementioned three (3) units of fire trucks to the Quezon City Fire District, in order to further strengthen its firefighting capability and promote public safety;

WHEREAS, upon donation, the Donee shall bear all expenses relative to the insurance, registration, maintenance, and other incidental costs, including fees associated with the transfer of ownership;

WHEREAS, three (3) distinct Deeds of Donation covering the three (3) fire trucks subject of this conveyance shall be duly executed between the Donor and the Donee and shall be deemed integral parts of this Resolution for all legal intents and purposes.

NOW, THEREFORE,


