

WHEREAS, Barangay San Jose, Quezon City, under the leadership of Punong Barangay Mario DR. Alcantara, Jr., was conferred the “Mark of Excellence” during the 2025 Metro Manila SubayBAYANI Awards held on October 7, 2025 at The Manila Hotel, Ermita, Manila;

WHEREAS, historically, Barangay San Jose was originally known as Barrio La Loma when it was still part of Caloocan in the 1930s, before becoming part of Quezon City;

WHEREAS, in 1946, the area was renamed Barrio San Jose as a sign of thanksgiving to St. Joseph, who was believed to have interceded for the safety and recovery of the community after the challenges brought by the Second World War;

WHEREAS, today, Barangay San Jose stands as a symbol of faith, resilience, and civic unity, values that continue to inspire its local government and residents in their pursuit of progress and public service;

WHEREAS, the SubayBAYANI Awards emphasize transparency, community participation, and measurable results in the management of government-funded projects, principles that Barangay San Jose consistently upholds in its programs and initiatives;

WHEREAS, this recognition reflects the barangay’s steadfast commitment to participatory governance, local accountability, and the empowerment of its citizens, in alignment with Quezon City’s thrust for inclusive and sustainable development;

WHEREAS, this achievement brings pride and distinction to Quezon City, highlighting Barangay San Jose’s important role in fostering effective local governance and citizen-centered service.

NOW, THEREFORE,


