A RESOLUTION RENEWING THE SPECIAL PERMIT OF POCKET ACES GAME DEPOT, INCORPORATED SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Pocket Aces Game Depot, Incorporated is a domestic corporation duly organized and existing under and by virtue of Philippine laws;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of an Electronic Games (E-Games) establishment through Resolution No. SP-7568, S-2018 on August 28, 2018;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

WHEREAS, the operation of E-Games is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);


WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Pocket Aces Game Depot, Incorporated subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Games establishment granted herein shall be subject to the following conditions:

1. the holding of E-Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of the E-Games establishment shall not include playing of games not related to or other than E-Games;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college, or university;
4. Pocket Aces Game Depot, Inc. shall remit a license fee of three percent (3%) of the gross receipts of the herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Quezon City Ordinance No. SP-2773, S-2018, as amended;
5. the Special Permit herein granted is non-assignable, non-transferable, and site-address specific; and
6. the establishment shall not be a nuisance to public safety and order.




