A RESOLUTION EXPRESSING THE QUEZON CITY COUNCIL'S SUPPORT FOR THE ESTABLISHMENT OF A COMMUNITY SERVICE HUB TO BE UTILIZED BY NON-GOVERNMENTAL ORGANIZATIONS (NGOs), IN LINE WITH THE CITY'S AGENDA OF INCLUSIVE GOVERNANCE, TO BE LOCATED IN DON A. ROCES AVENUE CORNER MOTHER IGNACIA STREET, BARANGAY PALIGSAHAN, DISTRICT IV, QUEZON CITY, THEREBY REVOKING QUEZON CITY RESOLUTION NO. SP-8255, S-2020

WHEREAS, the Quezon City Council recognizes the importance of inclusive governance in fostering community development and ensuring that all sectors of society are given opportunities to contribute to the City's progress;

WHEREAS, the City Council previously passed Quezon City Resolution No. SP-8255, S-2020, authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte, in behalf of the Local Government of Quezon City, to sign the renewal of contract of lease between the Rotary International District 3780, Rotary Center Foundation, Incorporated for the rental of a property for a period of twenty-five (25) years from July 1, 2020 to June 30, 2045, located at Don A. Roces Avenue corner Mother Ignacia Street, Barangay Paligsahan, Quezon City;

WHEREAS, the said Resolution did not direct the City Mayor to renew any lease agreement, but merely granted the City Mayor the authority to do so, subject to proper determination as the circumstances may warrant;

WHEREAS, the circumstances warrant that the subject public property be utilized to align with the City's agenda of inclusive governance to all by proposing its establishment as a Community Service Hub to be utilized by City-accredited non-governmental organizations (NGOs);

WHEREAS, the establishment of a community service hub will provide NGOs with a dedicated space to deliver essential services and implement programs that address the needs of various sectors of the community, thereby advancing the City's commitment to inclusive governance and equitable development.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express, the City Council's support for the establishment of a Community Service Hub to be utilized by Non-Governmental Organizations (NGOs), in line with the City's agenda of inclusive governance, to be located in Don A. Roces Avenue corner Mother Ignacia Street, Barangay Paligsahan, District IV, Quezon City, thereby revoking Quezon City Resolution No. SP-8255, S-2020.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Office of the City Mayor and relevant departments for their information and appropriate action.
