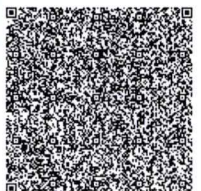




WHEREAS, his success on the world stage brings immense pride and honor to District IV, Quezon City, and to the entire Filipino Nation.

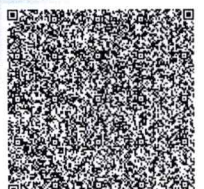
NOW, THEREFORE,


