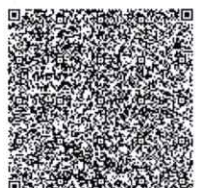
A RESOLUTION GRANTING A SPECIAL PERMIT TO TRIPLE 8 AMUSEMENTS AND DEVELOPMENT CORPORATION TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT LOCATED AT K0101 NOVA STOP, ROBINSONS PLACE, QUIRINO HIGHWAY, BARANGAY PASONG PUTIK, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Triple 8 Amusements and Development Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for a Special Permit to operate an Electronic Games (E-Games) establishment located at K0101 Nova Stop, Robinsons Place, Quirino Highway, Barangay Pasong Putik, District V, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of the Traditional and Electronic Bingo Games through Quezon City Resolution No. SP-9853, S-2024;



WHEREAS, this application is an additional game offering from the existing approved Resolution with the same venue;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City ordinances, authorizes the City Council to grant or renew a Special Permit to business activities of the same nature;

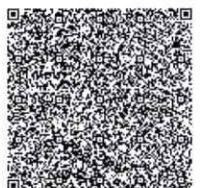
WHEREAS, on August 15, 2024, the change of operator from B-7 Amusement Corporation was approved and transferred in favor of the Triple 8 Amusements and Development Corporation by the Philippine Amusement and Gaming Corporation.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Triple 8 Amusements and Development Corporation to operate an Electronic Games (E-Games) establishment located at K0101 Nova Stop, Robinsons Place, Quirino Highway, Barangay Pasong Putik, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Games establishment located at K0101 Nova Stop, Robinsons Place, Quirino Highway, Barangay Pasong Putik, District V, Quezon City, granted herein shall be subject to the following conditions:

1. the holding of Electronic Games establishment shall be in accordance with the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR);
2. the operation of an Electronic Games shall not include the playing of games not related to or other than Electronic Games;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college, or university;
4. Triple 8 Amusements and Development Corporation shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution in accordance with Section 25 of Quezon City Ordinance No. SP-2773, S-2018, as amended;




5. *this Resolution is non-assignable, non-transferable, and site-address specific; and*
6. *the establishment shall not be a nuisance to public safety and order.*

RESOLVED FINALLY, that the Special Permit to operate an Electronic Games establishment granted to Triple 8 Amusements and Development Corporation shall be valid for a period of three (3) years from the approval of this Resolution and may be renewed by the City Council.
