A RESOLUTION GRANTING THE ISSUANCE OF A SPECIAL PERMIT TO TITOY'S OTB PLACE TO OPERATE AND MAINTAIN AN OFF-TRACK BETTING STATION LOCATED AT NO. 49 BALINGASA STREET, BARANGAY BALINGASA, BALINTAWAK, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE GAMES AND AMUSEMENT BOARD

WHEREAS, Titoy's OTB Place, a domestic corporation duly registered and existing under and by virtue of Philippine laws, with business address at No. 49 Balingasa Street, Barangay Balingasa, Balintawak, District I, Quezon City, is applying for the operation of an Off-Track Betting Station;

WHEREAS, the applicant is authorized to maintain and operate an Off-Track Betting Station, subject to compliance of necessary requirements;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, the issuance of a Special Permit to Titoy's OTB Place to operate and maintain an Off-Track Betting Station located at No. 49 Balingasa Street, Barangay Balingasa, Balintawak, District I, Quezon City, subject to the rules and regulations promulgated by the Games and Amusement Board.

RESOLVED FURTHER, that the authority to operate an Off-Track Betting Station granted herein shall be subject to the following conditions:

1. the subject establishment shall not be a nuisance to public safety and order;
2. Titoy's OTB Place complies with all clearances, documentary requirements, and other applicable local and national laws;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college or university;
4. Titoy's OTB Place, shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25, Article III of Quezon City Ordinance No. SP-2773, S-2018, as amended; and

5. *this Resolution is non-assignable, non-transferable, and site-address specific with validity period of three (3) years.*
