WHEREAS, during the said founding congress, Honorable Guillermo "Willie" C. Altuna of Quezon City was elected as the first National Chairman of the Philippine Councilors League, firmly establishing the historic and foundational role of Quezon City in the organization;

WHEREAS, Quezon City has remained an active and consistent contributor to the Philippine Councilors League, with its councilors continuously participating in national leadership, policy discussions, and organizational reforms of the League;

WHEREAS, Honorable Wencerom Benedict C. Lagumbay has been serving as President of the Philippine Councilors League – Quezon City Chapter since July 2022 up to the present, providing steady leadership and representing Quezon City with distinction in various PCL activities;

WHEREAS, pursuant to the Constitution and duly approved amendments of the Philippine Councilors League, National and Island Officers are elected by the Provincial Federation and City Chapter Presidents, reflecting a representative and democratic process within the organization;

WHEREAS, on March 3, 2026, during the Philippine Councilors League National and Island Officers Elections, Honorable Wencerom Benedict C. Lagumbay, City Councilor of Quezon City, was duly elected as Treasurer for the Island of Luzon, earning the trust and confidence of his fellow local legislators;

WHEREAS, his election to an island-wide leadership position affirms his competence, integrity, and commitment to public service, and further highlights Quezon City's continued leadership within the Philippine Councilors League.


