WHEREAS, the Quezon City Government, as a local government unit, is mandated to ensure the effective delivery of basic services and the efficient administration of its departments, including the City Planning and Development Department (CPDD), which is a mandatory department under the Local Government Code of 1991;

WHEREAS, pursuant to Civil Service Commission (CSC) Memorandum Circular No. 12, Series of 2024 or the Revised Policies on Secondment, secondment is a temporary movement of an official or employee from one government agency to another, governed by a duly executed Memorandum of Agreement (MOA) on Secondment, and which shall require the issuance of a new appointment;

WHEREAS, consistent with the aforesaid policy, a MOA on Secondment dated March 17, 2026 was duly executed by and among the University of the Philippines, as the Parent Agency, the Quezon City Government, as the Recipient Agency, and Dr. Jose Edgardo A. Gomez, Jr., EnP, as the Secondee, covering the period therein specified, and providing, among others, for the terms and conditions of his temporary assignment, including compensation, duties, and responsibilities;

WHEREAS, under said MOA on Secondment, the compensation, salaries, and benefits of the Secondee are to be borne by the Quezon City Government without diminution of benefits, in accordance with the provisions of CSC Memorandum Circular No. 12, Series of 2024;

WHEREAS, by virtue of an Office Order issued by the City Mayor, Honorable Ma. Josefina G. Belmonte, Dr. Jose Edgardo A. Gomez, Jr., EnP was designated as Officer-in-Charge of the City Planning and Development Department (CPDD), with authority to perform all functions and duties appurtenant to the position;

WHEREAS, Dr. Jose Edgardo A. Gomez, Jr., EnP is a Professor IV at the University of the Philippines School of Urban and Regional Planning (UP SURP) and has served as a consultant to various local government units in the fields of urban planning, governance, and development management;

WHEREAS, his Secondment to head and manage the CPDD is essential to ensure continuity in planning, policy formulation, and implementation of development programs of the City;

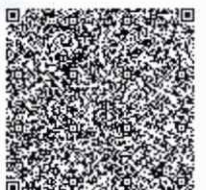
WHEREAS, CSC Memorandum Circular No. 12, Series of 2024, expressly provides that Secondment to mandatory department head positions in local government units shall require the concurrence of the majority of all the members of the Sanggunian through a Resolution;

WHEREAS, Dr. Jose Edgardo A. Gomez Jr., EnP possesses the necessary qualifications, experience, and expertise in the field of urban planning, governance, and development management and is deemed competent to discharge the duties and responsibilities of the City Government Department Head III of the CPDD.

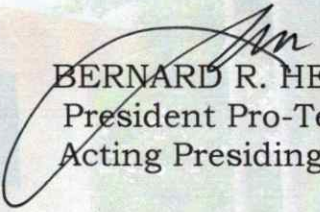
