A RESOLUTION GRANTING TRIPLE 8 AMUSEMENTS AND DEVELOPMENT CORPORATION A SPECIAL PERMIT TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT LOCATED AT 2/F BERKELEY SQUARE, COMMONWEALTH AVENUE, BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Triple 8 Amusements and Development Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, is applying for a Special Permit to operate an Electronic Games (E-Games) establishment located at 2/F Berkeley Square, Commonwealth Avenue, Barangay Matandang Balara, District III, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of a Traditional and Electronic Bingo Games establishment through Quezon City Resolution No. SP-9846, S-2024;

WHEREAS, this application is an additional game offering from the aforementioned existing approved Resolution with the same venue;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City ordinances, authorizes the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, Triple 8 Amusements and Development Corporation a Special Permit to operate an Electronic Games (E-Games) establishment located at 2/F Berkeley Square, Commonwealth Avenue, Barangay Matandang Balara, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Games establishment located at 2/F Berkeley Square, Commonwealth Avenue, Barangay Matandang Balara, District III, Quezon City granted herein shall be subject to the following conditions:

1. the holding of E-Games shall be in accordance with the rules promulgated by the PAGCOR;
2. the operation of an E-Games establishment shall not include the playing of games not related to or other than E-Games; and
3. the establishment is mandated to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age.

RESOLVED FINALLY, that the Special Permit to operate an E-Games establishment granted herein shall be valid for a period of three (3) years from the approval of this Resolution and may be renewed by the City Council.
