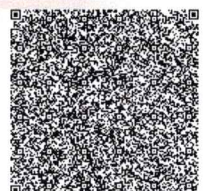

RESOLUTION NO. SP- **10512**, S-2026

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXTEND FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PHP4,500,000.00) AND HUMANITARIAN AID IN THE FORM OF MENTAL HEALTH AND PSYCHOSOCIAL SUPPORT SERVICES AND VARIOUS GOODS TO LOCAL GOVERNMENT UNITS SUBSTANTIALLY AFFECTED BY THE 7.8 MAGNITUDE EARTHQUAKE ON 08 JUNE 2026 IN SUPPORT OF THEIR DISASTER RESPONSE, RECOVERY, AND REHABILITATION TO BE CHARGED AGAINST THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF)

WHEREAS, on 08 June 2026 at 7:37 A.M., a magnitude 7.8 earthquake of tectonic origin struck the Municipality of Maasim, Sarangani Province, at a depth of thirty-three (33) kilometers, causing significant ground shaking across Mindanao and adjacent areas, with reported earthquake intensities ranging from Intensity I to Intensity VIII in Regions VIII, IX, X, XI, XII, the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), and the CARAGA Region, resulting in damage to properties and infrastructure, disruption of essential services, and the occurrence of aftershocks;

WHEREAS, as of June 14, 2026, the Office of Civil Defense recorded 61 deaths from Region XII and Region XI. The earthquake has also led to massive displacement with 173,000 families or approximately 724,000 persons affected, needing shelter, food, water, and other services;

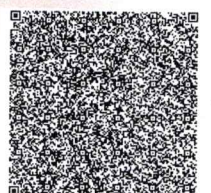
WHEREAS, the Municipality of Jose Abad Santos, Davao Occidental; Municipality of Malapatan, Sarangani Province; Municipality of Sarangani, Davao Occidental; and General Santos City declared a State of Calamity and continue to undertake emergency response, relief, recovery, rehabilitation, and reconstruction activities in view of the adverse effects of the magnitude 7.8 earthquake;

WHEREAS, in the spirit of solidarity and humanitarian commitment, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC) issued QCDRRMC Resolution No. 4, s. 2026 to extend financial assistance and humanitarian aid in the form of mental health psychosocial services and various goods to substantially affected local government units;

WHEREAS, this will help alleviate the hardship of affected communities and aid in ongoing disaster response, recovery, and rehabilitation efforts of the affected areas.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to extend financial assistance in the total amount of Four Million Five Hundred Thousand Pesos (Php4,500,000.00) and humanitarian aid in the form of Mental Health and Psychosocial Support Services and various goods to local government units substantially affected by the 7.8 magnitude earthquake on 08 June 2026 in support of their disaster response, recovery, and rehabilitation to be charged against the Local Disaster Risk Reduction and Management Fund (LDRRMF).



RESOLVED FURTHER, that the following financial assistance be extended to the affected local government units:

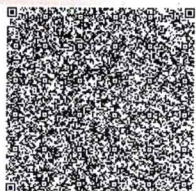

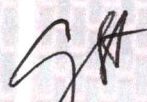


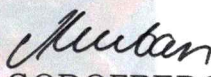
