NOW, THEREFORE,

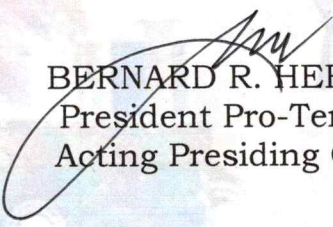

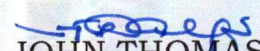
