WHEREAS, Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, was enacted to adopt a systematic, comprehensive, and ecological solid waste management program;

WHEREAS, the said law mandates the creation of a City Solid Waste Management Board, which shall have the responsibility to develop the City's Solid Waste Management Plan, consistent with the National Solid Waste Management Framework;

WHEREAS, the 16th Quezon City Council enacted City Ordinance No. SP-1512, S-2005, as amended by City Ordinance No. SP-2387, S-2015, creating the Quezon City Solid Waste Management Board, and was subsequently reconstituted through Executive Order No. 11, Series of 2015, Executive Order No.11-A, Series of 2018, Executive Order No. 30, Series of 2022, and Executive Order No. 36, Series of 2023, all issued by the Office of the City Mayor;

WHEREAS, the City's Updated Ten (10)-Year Solid Waste Management Plan, created and developed by the Quezon City Solid Waste Management Board, was approved on 09 December 2025 by the National Solid Waste Management Commission (NSWMC) through Resolution No. 1074-A, Series of 2025, a "Resolution approving the 10-year Solid Waste Management (SWM) Plan of Quezon City," subject to the City Government's submission of the final version of the Plan with a Sangguniang Panlungsod Resolution;

WHEREAS, on 10 February 2026, the Department of Environment and Natural Resources – Environmental Management Bureau (DENR-EMB) National Capital Region officially transmitted the NSWMC Resolution No. 1074-A, Series of 2025 to the Quezon City Government;

WHEREAS, the Quezon City Solid Waste Management Board, through SWMB Joint Resolution No. 1, Series of 2026, formally submitted to the Quezon City Council the final version of the Updated Ten (10)-Year Solid Waste Management Plan of Quezon City (2025-2034) for confirmation and adoption.

NOW, THEREFORE,

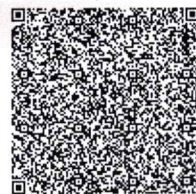

RESOLVED FURTHERMORE, that the strategies and actions embodied in the Plan shall be integrated into the City's annual investment programs and budgetary processes.

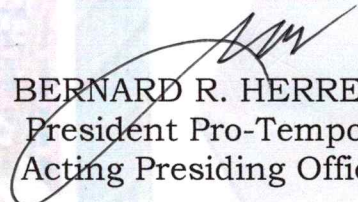
RESOLVED FURTHERMORE, that copies of this Resolution be furnished to all concerned offices for their information, guidance, and appropriate action.
