WHEREAS, the Quezon City Government recognizes the vital role of barangays as frontliners in the delivery of basic services and the implementation of programs for the welfare of their constituents;

WHEREAS, to support and enhance the operational efficiency of barangay offices and facilities, the Quezon City Government procured various air conditioning units intended for distribution to selected barangays;

WHEREAS, the said air conditioning units have already been delivered and issued to the recipient barangays and are presently being utilized for public service;

WHEREAS, the formal transfer of ownership of the said units to the recipient barangays is necessary to ensure proper accountability, recording, and maintenance of government properties;

WHEREAS, the donation of said units is consistent with the Quezon City Government's commitment to strengthen barangay operations and improve public service delivery at the community level;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor is authorized to represent the City in all its business transactions and sign contracts and other documents upon authority of the Sangguniang Panlungsod;

WHEREAS, there is a need for the Sangguniang Panlungsod to grant authority to the City Mayor to execute the Deeds of Donation and Acceptance and other related documents.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate various air conditioning units to Barangay Quirino 2-A, Quezon City, and to authorize the execution of the corresponding Deed of Donation and Acceptance.

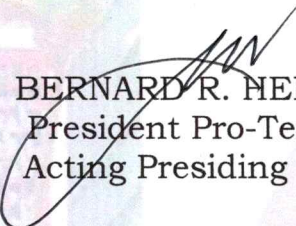

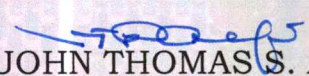
