RESOLUTION NO. SP-10545, S-2026

A RESOLUTION RENEWING THE SPECIAL PERMIT OF TRIPLE 8 ENTERTAINMENT COMPANY INCORPORATED FOR THE ESTABLISHMENT AND OPERATION OF AN ELECTRONIC BINGO AT UPPER GROUND FLOOR, PUREGOLD CUBAO, AURORA BOULEVARD, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Triple 8 Entertainment Company Incorporated, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Robert Yang, is applying for the renewal of its Special Permit to operate an Electronic Bingo Games located at Upper Ground Floor Puregold Cubao, Aurora Boulevard, Barangay Socorro, District III, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-9238, S-2023;

WHEREAS, the operation of an Electronic Bingo is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

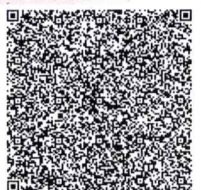
WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Triple 8 Entertainment Company Incorporated for the establishment and operation of an Electronic Bingo at Upper Ground Floor, Puregold Cubao, Aurora Boulevard, Barangay Socorro, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo granted herein shall be subject to the following conditions:

1. the holding of E-Bingo shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. the operation of an E-Bingo shall not include playing of games not related to or other than E-Bingo Games;
3. the operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college or university;
4. Triple 8 Entertainment Company Incorporated shall remit a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution, in accordance with Section 25 of Quezon City Ordinance No. SP-2773, S-2018, as amended; and
5. this Resolution is non-assignable, non-transferable and site-address specific.



RESOLVED FINALLY, that this renewal of a Special Permit to operate an Electronic Bingo Hall shall be valid for a period of three (3) years from the approval of this Resolution and may be renewed by the City Council.
