A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACQUIRE THROUGH NEGOTIATED SALE AND TO EXECUTE A DEED OF ABSOLUTE SALE FOR THE PURCHASE OF PARCELS OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 004-2025005531 AND 004-2025005532 REGISTERED UNDER THE NAMES OF ANTONY C. SYQUIA, MARRIED TO NINA GIZELLA D. SYQUIA, ET AL., WITH AN AGGREGATE AREA OF TWENTY THOUSAND ONE HUNDRED THIRTY-THREE (20,133) SQUARE METERS, MORE OR LESS, LOCATED AT BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, INTENDED FOR THE DEVELOPMENT OF A SOCIALIZED HOUSING PROJECT FOR THE BENEFIT OF QUEZON CITY'S INFORMAL SETTLER FAMILIES (ISFs)

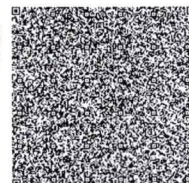

WHEREAS, the Quezon City Government, through the Housing, Community Development and Resettlement Department (HCDRD), in its desire to provide greater opportunities to a significant number of Quezon City informal settlers/residents to own an in-City, decent, and affordable housing, has been relentless in its efforts to expand its socialized housing projects;

WHEREAS, Antony C. Syquia, married to Nina Gizella D. Syquia, et al., the owners of the above-described parcels of land, in support of the Quezon City Government's objective, have expressed willingness to sell the subject properties to the Quezon City Government through a negotiated sale;

WHEREAS, the purpose of acquiring the above-described properties is to develop the same into a socialized housing project for the benefit of the informal settler families in Quezon City who will be screened and pre-qualified by a Beneficiary Selection Committee;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

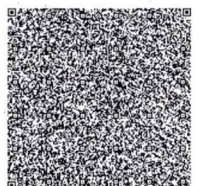
NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to acquire through negotiated sale and to execute a Deed of Absolute Sale for the purchase of parcels of land covered by Transfer Certificate of Title Nos. 004-2025005531 and 004-2025005532 registered under the names of Antony C. Syquia, married to Nina Gizella D. Syquia, et al., with an aggregate area of twenty thousand one hundred thirty-three (20,133) square meters, more or less, located at Barangay Payatas, District II, Quezon City, intended for the development of a socialized housing project for the benefit of Quezon City's Informal Settler Families (ISFs).
