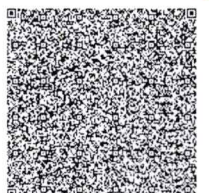

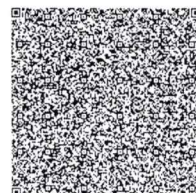
NOW, THEREFORE,

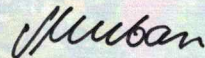

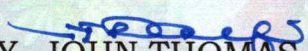
