The Committees on Laws, Rules & Internal Government; and City Planning, Building & Zoning recommended approval, with amendment:

- to include all Councilors present during the Committee Hearing as Co-Introducers.

After moving for its approval, Councilor Calalay made on record that the subject lot area is classified as a Medium-Density Residential Sub-Zone (R-2-A) where commercial use is allowed, and the project is compliant with all provisions for issuing a certificate of exception. All requirements were completed.

After which, on motion, duly seconded, PR22CC-1440 was APPROVED on its second reading, with an amendment to include all councilors present as co-introducers of the measure.

### MINUTES, 114<sup>th</sup> REGULAR SESSION, MONDAY, JUNE 23, 2025

The Committees on Laws, Rules & Internal Government; and City Planning, Building & Zoning recommended approval, with amendments and/or remarks:

- will submit an amended version; and
- to include all Councilors present during the Committee Hearing as Co-Introducers.

The Committee on General Services and Patrimonial & Proprietary Property recommended approval, with amendment:

- to include all Councilors present during the Committee Hearing as Co-Introducers of the measure.

Councilor Belmonte (Irene) moved for the approval of PO22CC-419.

Accompanied by a PowerPoint presentation, the Lady Proponent stated that this ordinance pertains to the rezoning of Kapiligan Street and Galas District, which will affect the land use and development of the streets both in Barangays Doña Imelda, Santol, Sto. Niño, and San Isidro Galas; will also impact five streets within the Galas District. The ordinance aims to optimize urban development and address other evolving needs of the community in the said areas.

Further, Councilor Belmonte (Irene) outlined the legal basis for the proposed ordinance, viz: the Local Government Code of 1991 (RA No.7160) providing legal framework for Local Government Units to zone and regulate land use within their respective jurisdiction; and Quezon City Comprehensive Zoning Ordinance of 2016 (SP-2502, S-2016) provides for the City Zoning Review Committee to review and amend the zoning every six (6) months and make recommendations thereof, zoning and assessment, and documentation. The Lady Councilor emphasized the importance of zoning regulations in protecting property values, ensure compatible development, promote public health and safety, preserve community character, and manage growth and development.

Furthermore, the Proponent clarified that this discusses about rezoning a residential zone into a commercial zone, and they have to understand the following classifications under the Comprehensive Zoning Ordinance, viz: *Residential Zone*, Low-Density Residential Zone (R-1), Sub-Zone (R-1-A), Medium Density Residential Zone (R-2), Sub-Zone (R-2-A), and High Density Residential Zone (R-3); *Commercial Zone*, Minor Commercial Zone (C-1), Major Commercial Zone (C-2), and Metropolitan Commercial Zone (C-3); and *Industrial Zone*, Low Intensity Industrial Zone (I-1) and Medium Intensity Industrial Zone (I-2).

Moving on, the Proponent relayed that: the neighborhood of Kapiligan Street came up with a proposal of rezoning from Medium Density Residential Zone (R-2) to Major Commercial Zone (C-2) aiming to support the increase activity and provide necessary infrastructure to meet the community evolving needs; Kapiligan Street is adjacent to Araneta Avenue, a gateway to the North and South Luzon Expressways; not the whole Kapiligan Street is covered by this, but only one lot deep, particularly deep east side of Araneta Avenue to the northeast side of Guirayan Street; based on the City Assessor's Office, out of 159 parcels of land, only two (2) were classified through exemption, 154 lots were still classified as a residential zone, and three (3) lots are classified as R-3.

For better understanding, the Lady Proponent showed the graph of the current land use of Kapiligan Street, showing the area and percentage of those occupying the residential, commercial, and industrial zones, including the informal settlers, utilities, and those under construction. However, she clarified that some residential areas there are already doing business as a commercial area. In fact, as per the Zoning Administration Unit, out of 167 business applications, 100 were given a conditional locational clearance (operating as a commercial within a residential zone); 63 were disapproved; and four (4) have exemptions. About 91 business permits have been issued by the Business Permits and Licensing Department (BPLD), which include retailers, wholesalers, contractors, apartments, commercial buildings, administrative offices, warehouses, and other small-scale businesses. With this, she stressed the need to rezone said street.

In addition, Councilor Belmonte (Irene) presented the existing condition of Kapiligan Street by showing pictures of structures that seem residential on the outside but are actually operating commercially, commercial structures, road conditions, and the informal settlers at the corner of Palanza Street. As such, rezoning of the area from R-2 to C-2 was recommended, shifting the development trend toward commercialization with mixed-use projects.

Discussing the Galas District covered by Barangays San Isidro, Sto. Niño, and some part of Santol, the Proponent remarked that the barangay chairperson of Barangay San Isidro Galas already requested the previous City Council to rezone said area from R-3 to C-1, covering Cuatro de Julio and Luzon Avenue. The same with Kapiligan Street, there are already lots of business applications, hence the demand to rezone the said area. On April 2, 2024, the TWG of the Zoning Review Committee already defined the limits to rezone the Galas District. There are also some recommendations to rezone the other street, but they focused on this one because of the presence of the Galas Public Market in Luzon Avenue. The street profile of the Galas District and the existing conditions of Union Civica and Liberation Street, Luzon Avenue, Visayas Avenue, and Mindanao Avenue were also presented. Pertaining to issues therein, the Proponent enumerated: on-street parking, the presence of street vendors contributing to the traffic congestion, business establishments utilizing sidewalks for their operation, and narrow road right-of-way.

Again, Councilor Belmonte (Irene) emphasized that they are only rezoning one lot deep of Cuatro de Julio Street, Union Civica Street, Liberation Street, Luzon Avenue and Visayas Avenue, which would increase business activity in the area, helps Galas Public Market to reflect its primarily commercial use, and extends the said streets to city limits. She clarified that Mindanao Avenue will remain R-3, as it is mainly residential with light commercial activity. Several public consultations were conducted for this ordinance, viz: On July 9, 2024, the Zoning Review Committee presented the rezoning of the covered area, thereby approving Resolution No. ZAU24-001, S-2024; letter received from the City Legal Department, dated January 6, 2025, interposing no objection to the ordinance; letter from the City Administration, dated December 19, 2024, recommending for further validation of the proposal to ensure compliance with zoning regulations; conducted City Council's public consultations, dated November 21, 2024 and February 12, 2025, and invited all stakeholders including barangay officials, business owners, and lot owners.

During the public consultation, the Proponent recalled that the issue raised was the RPT that will be collected, which was already clarified. There were also recommendations from the concerned barangays for the passage of the ordinance, through a barangay resolution.

The Presiding Officer, Acting Vice Mayor Herrera, congratulated and thanked the Proponent for a very comprehensive explanation of this very important legislation. And to his other query, the Proponent stated that the ordinance has been prepared thoroughly, considering numerous issues, including public surveys and public consultations, and that the barangay also conducted their own public consultation.

The Proponent likewise encouraged the barangays to submit their proposals on this matter.

There being no other clarifications from the Council, the discussion was terminated.

Finally, on motion, duly seconded, **PO22CC-419** was **APPROVED** on its second reading, with the following modifications:

- An amended version of the ordinance shall be submitted to clarify the technical specifications including the lot numbers; and
- To include all councilors present as co-introducers of the measure.

Upon moving for its approval, the Majority Floor Leader, Councilor Delarmente, expressed that this ordinance is granting monthly communication allocation to the city government's officials and employees with Salary Grade 24 and above. She added that during the committee hearing, it was established that said allocation had already been included in the city budget, hence the presence of the Certificate of Availability of Fund (CAF) for this purpose.

With no other manifestations, on motion, duly seconded, PO22CC-494 was APPROVED on its second reading, with amendment to include all councilors present as co-introducers of the measure.

The Committees on Laws, Rules & Internal Government; Micro, Small & Medium Business & Entrepreneurship Development and Cooperatives; and Ways & Means recommended approval, with amendment:

Similarly, as moved by the Majority Floor Leader, duly seconded, PR22CC-1449 was APPROVED on its second reading, with amendment to include all councilors present as co-introducers of the measure and with the following manifestations:

- It authorizes Mayor Belmonte to enter into a memorandum of agreement with the tenants of the commercial stalls at the Quezon Memorial Circle (QMC);
- The city government is currently in the process of renovating the QMC, which also includes the tenants therein; and
- The measure was discussed in the committee hearings and endorsed by the head of the QMC.

Subsequently, upon motion of the Majority Floor Leader, the rules were suspended.

Considering that it is the 22<sup>nd</sup> City Council's last session, Majority Floor Leader moved to approve on third/final reading all measures approved in the day's session under second reading.

Hearing no objection, all the measures approved in the day's session under second reading were APPROVED/PASSED on third/final reading.

Thereafter, the rules were restored.
