- The Quezon City Bangsamoro Affairs Service Office and the Quezon City Gender and Development Office are hereby tasked to lead the implementation of activities to be conducted in observance of the Quezon City Hijab Day to effectively meet the objectives of this ordinance.

- The creation of the Quezon City Tourism Department was sustained by various approved ordinances of the city;
- There are some plantilla positions in the current staffing pattern of the QCTD that need re-alignment and rectification, following the Position Titles of Department of Budget and Management Circular No. 137, S-2021;
- Currently, there are 156 Plantilla personnel in the Quezon City Tourism Department;
- As per the HRMD's recommendation, thirteen (13) new Plantilla positions will be created while ten (10) will be abolished;
- During the joint hearing of the Committees on Laws and Appropriations, HRMD and City Budget Officers discussed the need to replace the salaries of the existing 10 Plantilla positions with the new 13 positions. With the help of Councilors Shay Liban and Irene Belmonte, it was agreed and assured by the Budget Department that any budget deficit would be refunded from the Other Personnel Benefit of the Mayor's Office;
- The Presiding Officer conveyed full support for this measure; and

<u>PO22CC-439</u> — ORDINANCE ADOPTING REVISED CRITERIA AND GUIDELINES FOR THE SEAL OF GOOD HOUSEKEEPING IN ALL BARANGAYS OF QUEZON CITY, REPEALING ORDINANCE NO. SP-3188, S-2023, AS AMENDED BY ORDINANCE NO. SP-3244, S-2024 (Introduced by Councilors JOSE MARIA M. RODRIGUEZ and DOROTHY A. DELARMENTE, M.D.)

The Committees on Laws, Rules & Internal Government; and Appropriations recommended approval, during their Joint Hearing with amendments and/or remarks:

- will submit an amended version;
- to include Councilors Victor "Vic" Bernardo and Emmanuel Banjo A. Pilar as Main-Introducers; and
- to include all Councilors present during the Committee Hearing as Co-Introducers.

The Committee on Barangay Affairs recommended approval.

On motion of Councilor Rodriguez, duly seconded, **PO22CC-439** was **APPROVED** on its second reading, with the following manifestation and revisions:

- This proposal is intended to revise Ordinance No. 2273, S-2014, entitled: "An ordinance adopting the Seal of Good Housekeeping in all barangays of Quezon City," as further amended by Ordinances Nos. SP-2523, S-2016, SP-2588, S-2017, SP-2898, S-2020, SP-3114, S-2022, SP-3125, S-2022, SP-3188, S-2023, and SP-3244, S-2024;
- The adoption of the Seal of Good Housekeeping in 2014, in close coordination with the Department of Interior and Local Government, is the first of its kind at the barangay level and was initiated by then Vice Mayor and now incumbent City Mayor Joy Belmonte;
- This recognizes the importance of commending the barangay's effort to attain the minimum government standards;
- Since its enactment in 2014, the Quezon City Barangay Seal of Good Housekeeping underwent several amendments;
- Enactment of this proposed ordinance will put to rest the unnecessary process of amending and revising the ordinance, saving time and resources for the city government, since the Technical Working Group created under this ordinance will have the power to formulate, through a resolution, the qualifications and guidelines for the Seal of Good Housekeeping, in consonance with the target goals of the city;
- Approval of this ordinance will aggressively institutionalize the spirit of good governance essential to barangay administration and development and empower barangay officials to aspire for excellence and take pride in all initiatives as they practice good governance in their respective barangays;

- As the basic political unit, the barangay serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community;
- Mayor Joy Belmonte once said, "If all barangays are all well governed, the city is well governed as well";
- The Presiding Officer stated that this measure is one of the priority measures of the City Mayor, which they fully support; and

#### - Amendments:

- To adopt all the amendments made during the hearings of the Committees on Barangay Affairs, Appropriations, and Laws;
- Section 13 shall be further amended stating that for the first year of the implementation of this ordinance, the amount of Twenty Million Pesos (PhP20,000,000.00) is hereby appropriated and for the succeeding years, the amount of Twenty-Five Million Pesos (PhP25,000,000.00) will be appropriated for this purpose;
- o To include all councilors present as co-introducers of this measure;
- To include the PDAO and GAD Office as members of the Technical Working Group;
