Councilor Belmonte (Irene) moved for the approval of PR22CC-1183.

Moving on to the period of discussion, the Lady Proponent narrated that:

- A portion of the subject property is classified as a Medium Commercial Zone where the nature and operation of this project are permissible, while at the back end of the property, specifically in Esteban Abada Street, is classified as a Medium Density Residential Zone (R-2) where the nature of the project is not permissible;
- The project failed to meet density, floor area ratio, height, and parking restrictions, but it could provide 359 car slots, which is compliant with the National Building Code or PD 1906;
- The Applicant had submitted all the necessary and mandatory requirements for this project;
- The issue of the traffic and environmental impact of the project has also been thoroughly discussed;
- As discussed during the hearing of the Committee on City Planning, Building & Zoning, the Applicant must submit a sustainability compliance certificate that will help achieve a green building upon the issuance of the building permit, as a condition for achieving a green building project; and

- Barangay Loyola Heights has approved Barangay Resolution No. LH305, S-2024 endorsing to the City Council for appropriate action the request for the exception of Sotern Land Corporation from the Quezon City Comprehensive Zoning Ordinance of 2016; the minutes of the public hearing regarding said barangay resolution were also submitted stipulating that all the questions therein have been answered by the Applicant and will also be formed as a condition for the approval of this project.

The Presiding Officer clarified that the proposed 43-storey condominium tower differs from the Project Evaluation, to which the Lady Proponent agreed to follow the Project Evaluation of the Zoning Administration Unit that is a 30-storey and 42-storey condominium tower and the amended title will be adopted accordingly.

The Presiding Officer clarified that the barangay resolution submitted was an endorsement to the City Council for appropriate action and not a resolution interposing no objection to this project.

The Lady Proponent confirmed this, emphasizing that the decision is left to the City Council for appropriate action.

The Proponent confirmed that a public hearing was held in the barangay, attended by the Barangay Council, stakeholders, homeowners association, and project representative.

Meanwhile, a recess was declared.

When the session resumed, the Presiding Officer stated that the Applicant must submit the necessary Certificate of Non-Coverage.

Councilor Belmonte (Irene) stated that a Certificate of Non-Coverage is required for the issuance of an exception from the Zoning Administration Unit and a requirement for the issuance of a building permit. However, as long as the Applicant submitted their application and receipt of the said applicant, it will suffice.

Again, the good Councilor reiterated that one of the conditions for the issuance of this certificate of exception is for the applicant to comply with the Green Building Code of Quezon City and build a connecting bridge from Ateneo de Manila University and Katipunan Avenue North Bound that is a two-lane with private and public access for pedestrians from Katipunan to the back and Esteban Abada.

There being no other clarifications, the discussion was terminated.
