#### I. OPENING PRAYER

Councilor De Leon led the opening prayer.

#### IV. CALL TO ORDER

The 106<sup>th</sup> Regular Session was called to order at 1:19 P.M. by the Presiding Officer, Vice Mayor Gian G. Sotto.

#### V. ROLL CALL

The Secretary to the Sangguniang Panlungsod, Atty. Alferos, called the roll.

#### VIII. PRIVILEGE HOUR

Having availed of the Privilege Hour, Councilor Ferrer expressed his plans to conduct a thorough inquiry in aid of legislation into the recent fire incident at Glacier North Refrigeration Services Corporation in Barangay Del Monte to understand the circumstances on the said incident, identifying potential gaps, safety protocols, and exploring legislative measures to prevent future similar tragedies.

Further, she narrated that a fire broke out in the ceiling of the 3<sup>rd</sup>-floor hallway of Glacier North facility on the early morning of January 20, 2025, and the fire spread out rapidly, fuelled by dense smoke and structural vulnerabilities, complicating firefighting efforts.

She said that despite efforts from emergency teams, including personnel from the Bureau of Fire Protection (BFP), Emergency Medical Services (EMS), Search and Rescue (SAR) teams from the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO), and fire volunteers, the damage was significant. Some of the storage units in the said facility were affected. She added that after the fire, BFP took action by restricting access to the building. However, the aftermath of the fire has presented another grave issue, a foul odor from spoiled meat that, despite some units remaining frozen estimated to be 4200 tons, others defrosted and began to rot.

The Speaker added that the Quezon City Government Incident Management Team (QC-IMT), composed of the QCDRRMO, the City Health Department, the City Veterinary Department, Department of Sanitation and Cleanup Works of QC, Traffic and Transport Management Department, City Engineering Department, and the QC Fire Department is currently working on 24/7 disinfection, pest control, flushing of residual waste, treatment of flushed water, air quality checks, methane level assessments, supervision and monitoring on the proper hauling and disposal of waste, however, there are concerns on long-term health risk on this.

With that, Councilor Ferrer requested to form an oversight committee to conduct a formal inquiry on the said incident, not only to shed light on the causes and shortcomings but to propose measures to prevent similar incidents in the future. She then asked, "Are there existing contingency plans on sanitation and proper waste disposal, fire, or any other disaster emergency plans for businesses? Should there be a requirement to have in-house trucking/hauling services for these establishments for immediate disposal of waste? What safeguards exist for communities that may be affected by such hazards? How can accountability be demanded from the private sector when the public is exposed to health and other such risks due to a lack of planning and urgency in response actions? Should it be allowed for frozen meat product storage with that capacity situated beside a hazardous gasoline station?"

Councilor Ferrer stated that the 22<sup>nd</sup> City Council, under Section 20 of its Internal Rules, is empowered to organize an oversight committee.

The Lady Speaker emphasized the importance of decisive action for the welfare of QCitizens, as their health, and safety must always remain their top priority, urging the City Council members to support and cooperate in conducting an inquiry to prevent future tragedies and protecting the well-being of their constituents.

In the period of interpellation, the Majority Floor Leader expressed her support for the measure. She said that the residents of District 1, particularly residents along FPJ Avenue, have been suffering for more than two (2) weeks already. The stench from the said spoiled meat is not healthy for the youth already, which they started removing five (5) days after the fire incident, and they could still smell the foul odor up to now. Councilor Delarmente said she could not imagine the health hazard and the danger that residents of District 1 could get from this foul smell, which could reach neighboring barangays and condominium units along EDSA.

She continued that upon her inquiry with various haulers, they were going to haul 4200 tons of spoiled meat from the facility. She said that on their end, they could only do so much because the private facility should be the ones handling the haulers and how they could discard said spoiled meat.

The Lady Councilor stressed that this is not enough because it has been two (2) weeks and they are not finished yet in hauling the said wastes. She added that her friend, an expert on this, mentioned to her that there is a chemical that they could use to neutralize the smell. She agreed with the Speaker to conduct a public inquiry into the matter and understand the company's plans.

In answer to the query of the Presiding Officer as to the improvement of the issue, the Speaker explained that a fire broke out on January 20, 2025, at 3:22 A.M. and declared fire out on January 21, 2025, and 67% of spoiled meat has been hauled and could be removed on Friday. She said that the storage emits a foul smell when opened by haulers, and the water flowing outside also has a bad smell despite being treated. The Sanitation Department is working 24/7 to address the issue.

Councilor Herrera agreed with the Majority Floor Leader that Glacier North Refrigeration Services Corporation should handle the problem, and the city will only assist them with it, but now become the sole responsibility of the Quezon City Government. He then suggested discussing with the company their responsibilities and what they are doing about it.

The Presiding Officer agreed with Councilor Herrera and was looking forward to form an oversight committee and to set a date right away for them to address the City Council.

At this juncture, the Majority Floor Leader moved to form an oversight committee and conduct an inquiry or hearing on this matter, while the Presiding Officer directed the Secretary to take note of the motion.

After which, the Privilege Hour was terminated.

In compliance thereto, the fund appropriated to the account of construction and heavy equipment was augmented to the account of motor vehicles under the Office of the City Administrator. Further, he said that it is recommended to omit the TTMD and replace it with the Office of the City Administrator since the fund was augmented to the said office. He emphasized that revising the previously approved resolution will be able to carry out the procurement of the two (2) units of motor vehicles, which are needed for the operations of the TTMD.

With no other clarification from the Body, as moved and duly seconded, **PR22CC-1269** was **APPROVED** on its second reading, with an amendment to include all councilors as co-introducers of this measure.

The Committee on Games & Amusements recommended approval.

Councilor Delarmente moved for the approval of PO22CC-423.

With great pride and purpose, the Majority Floor Leader presented the draft Quezon City Screen Commission (Screen QC) Ordinance, a landmark initiative that reaffirms the city's commitment to cultural excellence, and economic progress, and solidifies its position as the Film and Entertainment Capital of the Philippines.

Moving on, the Lady Proponent articulated that this ordinance reorganizes the Quezon City Film Development Commission (QCFDC) into the Quezon City Screen Commission (Screen QC), elevating it to a permanent department within the local government. She then enumerated its objectives, to wit:

- **Empowering the Screen Industry:** It expands the scope from traditional filmmaking to embrace all screen-based content, including television, streaming media, and digital platforms;
- **Structural Reform:** Establishing a well-defined organizational structure with dedicated divisions to address policy-making, permits, marketing, research, training, and special projects;
- **Streamlined Processes:** The ordinance introduces a centralized film permit system simplifying the requirements for local and international productions while offering incentives to attract investments;
- **Cultural and Economic Focus:** It supports the development of creative talent, the preservation of Filipino heritage, and the promotion of Quezon City as a global hub for screen content; and
- Flagship Projects: The QCinema International Film Festival continues as a centerpiece, highlighting the city's creativity on global platforms.

The Lady Councilor continued that this ordinance reflects a bold response to the evolving demands of the creative industries and the untapped potential of Quezon City as a cultural and economic powerhouse. It draws its inspiration and justification from international exemplars, national policies, and constitutional mandates that call for cultural preservation, artistic expression, and inclusive development. The rationale, she added, is rooted in these key pillars:

- **Adapting to Change:** In an era of technological transformation, the ordinance recognizes the growing importance of diverse forms of screen content beyond traditional cinema. This ensures Quezon City remains at the forefront of the creative industries;
- Catalyzing Economic Growth: The screen industry is a vital driver of job creation, investment, and global competitiveness. By institutionalizing support for this sector, Quezon City can attract filmmakers, boost local businesses, and enhance its international reputation; and

Councilor Delarmente remarked that Quezon City is already renowned as the "City of Stars." With this ordinance, they take an essential step forward in realizing their vision of formalizing their goal to be the "Film and Entertainment Capital of the Philippines." The establishment of Screen QC paves the way for a more dynamic, innovative, and inclusive creative ecosystem that reflects the city's identity and aspirations.

The Proponent also clarified that the Quezon City Screen Commission Ordinance is more than a policy reform—it is a declaration of their commitment to culture, creativity, and progress. She then enjoined her colleagues to embrace this opportunity to empower their artists, elevate the city, and inspire generations through the stories they share with the world. The Quezon City Screen Commission will centralize permits for shootings and events related to film and television in Quezon City. This measure passed through five committees and two public consultations, and is crucial for Quezon City's application as one of the UNESCO World Cities for Film, as it will centralize all relevant permits.

One of the principal introducers, Councilor Melendez, fully supported the proposed measure, offering suggestions for improvement during the public consultation, believing it would benefit the industry.

The Majority Floor Leader confirmed a public consultation that was engaging and learned from stakeholders and barangays. She emphasized that no one opposed the ordinance, especially the barangays. The ordinance will centralize permits for shooting locations, applying them in city hall instead of applying in the barangays. Barangays will still receive their share. This will standardize fees and reduce coordination with the PNP, MMDA, and DPOS, benefiting filmmakers.

The Presiding Officer concurred with the observations of the Lady Proponent and emphasized the need to continue promoting Quezon City as the venue for filmmakers, as it was once the capital of the country.

In addition, the Majority Floor leader emphasized the measure's aim to encourage local and international film producers to film in Quezon City. The QC Screen Commission will provide a list of filming venues, thereby opening the city to the international film industry and generating more jobs and businesses for the QCitizens.

On behalf of the 142 barangays of Quezon City, Councilor Rodriguez expressed full support for this measure, congratulating the Majority Floor Leader for this, and expressed willingness to provide input to the Technical Working Group if needed.

In return, the Majority Floor Leader expressed gratitude for the barangay's support and assured them that they would receive the dues and fees they deserved.

His Honor mentioned Quezon City as the City of Stars, hoping that the ordinance would make the world recognize the city's significance as a city of life, hope, faith, and love, to which the Proponent agreed.

There being no other comments, the discussion was terminated, following the adoption of the adopted modifications, to wit:

- To adopt all the amendments made during the committee hearings;
- To include all councilors present as co-introducers of the measure; and
- The amended version of this ordinance shall be submitted.

Finally, on motion, duly seconded, **PO22CC-423** was **APPROVED** on its second reading, as amended.

ORDINANCE MANDATING PO22CC-426 ALL BARANGAYS, SANGGUNIANG KABATAAN, AND QUEZON CITY GOVERNMENT DEPARTMENTS, OFFICES, AND AGENCIES TO PROMOTE THE CITY **OUEZON** HELPLINE **ENCOURAGING** 122, PRIVATE ESTABLISHMENTS TO SUPPORT ITS PROMOTION, AND FOR OTHER Councilors ALBERT ALVIN "Chuckie" L. **PURPOSES** (Introduced by ANTONIO III and BERNARD R. HERRERA)

The Committee on Laws, Rules & Internal Government recommended approval, with amendment:

- to include all Councilors present during the Committee Hearing as Co-Introducers.

The Committees on Public Affairs, Social and Mass Media Information & People's Participation; and Barangay Affairs recommended approval, with amendment:

- to include all Councilors present during the Committee Hearing as Co-Introducers.

Councilor Antonio moved for the approval of PO22C-426.

In his sponsorship speech, the Proponent imparted that:

- This ordinance seeks to mandate all barangays, Sangguniang Kabataan, and Quezon City Government departments, offices, and agencies to actively promote the Quezon City Helpline 122;
- It encourages private establishments within Quezon City to support this initiative by displaying their promotional materials and sharing information about the QC Helpline 122 on their online platforms;
- The Helpline serves as a vital tool for providing immediate assistance, reporting emergencies, and connecting residents with essential government services;
- Despite its significance, there is still room for improvement in awareness and utilization of this source:
- This ordinance addresses these challenges by integrating Helpline 122 into the Information, Education, and Communication (IEC) materials and online posts produced by the city's entities;
- By mandating government offices and agencies to feature QC Helpline 122 prominently in their communications, they could enhance public awareness and ensure that more residents have access to its critical services during emergencies and urgent situations;
- Involving private establishments in the promotion amplifies the reach of this initiative fostering a culture of cooperation between the public and private sectors for the safety and welfare of their citizens;

- The implementation of this ordinance will be overseen by the QCCSD, PAISD, ITDD, BCRD, and the BPLD;
- This initiative aligns with the city's goal of creating a safer and more responsive community by empowering residents with a reliable platform for emergency response, public safety, and other critical services; and
- It also demonstrates their commitment to proactive governance and collaboration with private establishments for the benefit of the OCitizens;

Completely agreeing with this measure, Councilor Herrera emphasized the importance of promoting the mental health hotline, as it is also used by non-QCitizens to address their concerns, and urged his colleagues to actively promote it and raise awareness of its importance.

Similarly, the Presiding Officer emphasized the significance of raising awareness about Helpline 122, stating that not all are aware of it but many of those online are aware of it.

The Majority Floor Leader likewise showed support for this ordinance. She cited a previous fire incident in Barangay Tandang Sora where neighbors took 20-30 minutes to call for help since they did not know the barangay's contact number as well as this Helpline 122. Inquiring if schools are included in this ordinance, she suggested schools to teach their students to automatically call Helpline 122 in case of emergencies and include it in their curriculum if possible.

The Proponent agreed with Councilor Herrera on the importance of the mental health hotline. After consulting with the QCCSD and requesting data on calls, he found out that more lives were saved using this hotline. He thanked the Majority Floor Leader for suggesting mandating schools to promote this, as well.

Following the termination of the period of discussions and amendments, on motion, duly seconded, PO22CC-426 was APPROVED on its second reading, with the amendment to include the names of Councilors Visaya, Lumbad, Valmocina, Delarmente, and Medalla as co-authors of this measure to be placed after the names of Councilors Antonio and Herrera, and all the other councilors present as co-introducers.

#### D. REVIEW & CONSIDERATION OF BARANGAY MATTERS
