- This measure does not prohibit parking itself, but rather the act of reserving or claiming exclusive parking rights on roads within the residential areas;
- This ordinance has undergone amendments to be enumerated in the period of amendments;
- Such practices of reserving parking spaces create road obstructions, worsen congestion, and lead to unnecessary disputes among residents;
- This ordinance prohibits the placement of barriers, unauthorized road markings, and personal guarding parking spots while allowing reasonable exemptions;

- To ensure compliance, penalties will escalate for repeat violations with enforcement led by the Quezon City Transport and Traffic Management Department (TTMD) in coordination with barangay officials and other agencies; and
- This measure has been previously forwarded to the TTMD and have no objection to this ordinance.

Since this ordinance passed through several hearings and the Committee on Laws, the Presiding Officer terminated the period of discussion.

For the amendments, the following modifications were adopted:

- The final amended copy of this ordinance shall be submitted, highlighting the following key changes:
 - Section 3 shall be entirely revised to instead of penalizing the parking of vehicles on two-way two roads in residential areas, this ordinance will only penalize the act of reserving a parking space, which includes:
 - a. Placing objects such as cones, chairs, signs, or any other barriers;
 - b. Painting or marking portions of the road to indicate exclusive parking rights;
 - c. Employing personnel or individual to guard or reserve a parking spot; and
 - d. Any other act that restricts the free and open use of the roads for parking;
 - Section 5 shall also be revised to instead of merely citing the basis of penalties, this ordinance will now specify the escalated penalties for each offense based on Ordinance No. SP-1465, S-2004, which prohibits individuals from reserving any portions of public streets for their exclusive use or parking space; hence it shall be read as follows:

First Offense Second Offense Third/Final Offense -

Fine of not less than PhP2,000.00; Fine of not less than PhP3,000.00; and

Fine of not less than PhP5,000.00 or imprisonment of not more than six (6) months or both at the sound discretion of the court:

Meanwhile, talking about the penalties for the third/final offense, the Presiding Officer inquired if the offender will have to pay PhP5,000.00 plus six months imprisonment or if it depends on the situation, to which the Lady Proponent clarified that if they are willing to pay the fine of PhP5,000.00, then they will no longer be imprisoned for six months.

- To include Councilors Ludovica, Medalla (Ram), and Pilar as co-authors of this measure while all the councilors present as co-introducers; and

Further, the Lady Councilor emphasized that the penalties to be implemented for this ordinance are based on the city's Traffic Ordinance No. SP-3172, S-2023, upon approval of the Council. Also, this proposal was endorsed by the TTMD signifying their no objection to the new traffic scheme of Barangay Central, and was transmitted last August 15, 2024.

There being no other discussants, on motion, duly seconded, **PO22CC-445** was **APPROVED** on its second reading, adopting the following modifications:
