- The recommendation is to conduct a comprehensive review of current policies to ensure they align with safety, accessibility, equity, and accountability, preventing financial exclusion of students.
- The measure calls for stricter adherence from DepEd and CHED regarding field trips or other activities outside the school;
- Schools should be responsible for safeguarding the safety of students and minors to prevent a repeat of the unfortunate incident.
