I. OPENING PRAYER

Councilor Liban (Shay) led the opening prayer.

II. NATIONAL ANTHEM

The Community Singing of the Philippine National Anthem.

III. COUNCILORS' CREED

The members of the City Council recited the Philippine Councilors' Creed led by Councilor Melendez.

IV. CALL TO ORDER

The 110th Regular Session was called to order at 1:22 P.M. by the Presiding Officer, Vice Mayor Gian G. Sotto.

V. ROLL CALL

The Secretariat, Ms. Bul-lalayao, called the roll.

There being a quorum, the Body proceeded with the calendar of business.

Meanwhile, the presence of former Councilor Pinggoy Lagumbay was acknowledged.

VI. APPROVAL OF THE MINUTES OF THE 109th REGULAR SESSION, HELD ON FEBRUARY 24, 2025.

There being no correction, observation, and modification, on motion, duly seconded, the minutes of the 109th Regular Session held on February 24, 2025 was **APPROVED**.

VIII. PRIVILEGE HOUR

Availing of the Privilege Hour, Councilor Ludovica stood before the Body on the issue of housing in District II. He stated that on May 17, 2003, during the time of President Gloria Macapagal-Arroyo, an Act was enacted, RA 9207, entitled: "AN ACT DECLARING CERTAIN PORTIONS OF THE NATIONAL GOVERNMENT CENTER SITE OPEN FOR DISPOSITION TO BONA FIDE RESIDENTS AND LOCAL GOVERNMENT OR COMMUNITY FACILITIES, CHARITABLE, EDUCATIONAL AND RELIGIOUS INSTITUTIONS ACTUALLY OCCUPYING THE SAME FOR SOCIOECONOMICS, CIVIC, AND RELIGIOUS PURPOSES, AMENDING FOR THIS PURPOSE PROCLAMATION NO. 1826, SERIES OF 1979 AND FOR OTHER PURPOSES." The National Government Center (NGC), known as GAO, located in Barangays Batasan Hills, Holy Spirit, Payatas, and Commonwealth, has beneficiaries of almost a hundred thousand families. Based on the said law, residents in the area were granted the chance to legally own their current lots, and they expressed their gratitude towards government officials for fulfilling their dreams of owning these properties.

The law has a good objective as the said properties could only be sold to qualified beneficiaries at Seven Hundred Pesos (PhP700.00). These properties are considered prime lots since they are located in the area of the National Government Center, where the House of Congress, the Sandigan Bayan, the Commission on Audit, the Civil Service Commission, and other government agencies are located. The said area was originally intended for government agencies, but there are already many Informal Settler Families (ISFs) living there, and many national politicians offered their assistance in addressing the issue.

The Speaker highlighted that almost 22 years ago (when he was still a barangay captain), nearly 30,000 of his constituents from Barangay Batasan Hills were beneficiaries of a land disposition program. He cited Section 5 (National Government Center Administration Committee) of the said Act, "There is hereby created a National Government Center Administration Committee to administer, formulate guidelines and policies, and implement the land disposition of the areas covered by this Act. The National Government Center Administration Committee shall be chaired by the Chairperson of the Housing and Urban Development Coordinating Council with the Chairperson of the Presidential Commission for the Urban Poor, the Mayor of Quezon City, the General Manager of the National Housing Authority, the Secretary of the Department of Environment and Natural Resources, the Secretary of the Department of Public Works and Highways, and two (2) representatives from duly recognized people's organizations, one (1) from the NGC East side and one (1) from the NGC West side." He continued that there was already an IRR on this stating therein the creation of the National Government Administration Office West and East, and was given the power to implement guidelines, particularly on reblocking.

Councilor Ludovica continued that upon the approval of the Community Development Plan (CDP), based on the consultation with the actual beneficiaries, maximum retention, and minimum dislocation of their structures were tackled, and they all adhered to the CDP as a requirement to their subdivision plan. He stressed that there were guidelines, however, it has a problem with the implementation. Punong Barangays are part of the Technical Working Group (TWG), which meets regularly, and many properties have been reblocked, and awarded, and some awardees already claimed their titles.

The Speaker explained that beneficiaries who were not accommodated on the said project were placed in the MRB or condominium style in Barangay Commonwealth. He said that the national government constructed 40 MRB buildings, but all were mismanaged. He emphasized that the National Housing Authority (NHA) should manage this law. There was a seed capital from Quezon City during the term of Mayor Herbert Bautista who proposed a PhP 20 Million budget each for NGC Eastside and NGC Westside to cover the needed expenses of the beneficiaries. During his term as Punong Barangay, almost 80% were reblocked depending on the NGC Administrator appointed by the NHA.

The Speaker has been encountering a persistent problem in a specific area, and he believes that the appointment of Atty. Jojo Conejero is the right time to address the issue. He cited an example of 36 MRB buildings in Barangay Commonwealth that were neglected, with only 100 of the 3,700 beneficiaries paying their monthly obligations. The buildings were not maintained, and no regulations were followed, making the said buildings unsafe to stay in. The Councilor expressed sadness over the findings from the Department of Building Officials that these buildings are unsafe to stay in.

Councilor Ludovica conveyed that a dialogue was conducted in Barangay Holy Spirit, with the LRB Republic Residents Federation of Homeowners Association (who were present in the day's session). Out of 300 household beneficiaries transferred from 2017 or 2020, only 83 were awardees. They have no individual meter from Meralco and are just using one meter. They sought the help of his representation to apply for an individual meter and to request a certification (just like the certification used by the Bistekville awardees) from the Housing Community Development and Resettlement Department (HCDRD) that they can use in applying for the said meter.

The Councilor mentioned that if a unit owner fails to pay their Meralco obligation, all unit owners will be affected as they are only using one Meralco meter. The residents experienced frequent overheating and burning of powerlines. He said that fire incidents are common in March due to faulty electrical wiring. He added that the residents therein mostly came from Barangays Culiat, Doña Imelda, and Commonwealth, Quezon City.

The Speaker emphasized the need to understand the cause of the slow administrative action of the NHA through the NGC Administrator as they need to self-reblock before approving their contract. He encountered the same problem in Barangay Payatas yesterday, where many rights were already sold due to slow action.

With that, he sought the help of the plenary, in aid of legislation, to conduct a dialogue with the NHA, People's Organization, qualified beneficiaries, and punong barangays. He said that Atty. Jojo Conejero is willing to coordinate and expedite the process.

In closing, the Speaker has requested to facilitate a meeting with the concerned government agencies, qualified beneficiaries, barangays, TWG of NGC, and his colleagues to address the matter promptly.

The Presiding Officer thanked the Speaker and expressed support for the said proposal, expressing further frustration with the delays in processing documents for the acquisition of the lots that they are occupying. His Honor agreed with the Speaker on the issue of "Katiyakan ng Paninirahan" and highlighted Mayor Joy Belmonte's priority for every family in Quezon City to have their own titled land. With that, the Presiding Officer suggested conducting a committee hearing, in aid of legislation, spearheaded by the Speaker, with the other concerned committee chairpersons, to have a dialogue with the NHA and possibly include the TWG.

Councilor Ludovica added that the Department of Public Works and Highways is mandated to allocate a yearly budget for the acquisition of private lands covered by the mentioned law.

There being no other discussions, the Privilege Hour was terminated.

When recognized, Coucilor Liban (Godie) moved for the approval of PR22CC-1265.

In his sponsorship speech, the Proponent manifested that the resolution pertains to the appointment of Carolina Onding Patalinghog as City Government Department Head III, Salary Grade 27, in the Social Services Development Department (SSDD).

In compliance with the provisions of Section 454, Republic Act No. 7160 of the Local Government Code, which provides, among others that heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of all the members of the Sangguniang Panlungsod, subject to civil service law, rules and regulations.

A one-minute recess was called, as requested by the Proponent.

When the session resumed, the Acting Presiding Officer (Councilor Delarmente) invited Ms. Carolina Patalinghog to answer some questions from the members of the City Council.

Subsequently, as inquired by Councilor Lagumbay about the number of employees in the SSDD, Ms. Patalinghog responded that they have 200 employees, and for social workers, they have 41 plantilla and 43 COS.

Councilor Lagumbay's queries were addressed by Ms. Patalinghog, who provided satisfactory answers to various questions, to wit:

➤ The financial assistance given to fire victims has increased from Two Thousand Pesos (PhP2,000.00) to Ten Thousand Pesos (PhP10,000.00) for house owners and Five Thousand Pesos (PhP5,000.00) for renters and sharers.

- ➤ Programs for senior citizens include social welfare assistance, subsidies, and a birthday package, recently started in January, and its pilot was held last October during the 85th Anniversary. The birthday package, includes groceries like milk, juice, spaghetti packages, cookies, and oatmeal, as Mayor Ma. Josefina G. Belmonte likes a healthy package for them. The solo parents make the "bayong" or the bag used for grocery packages.
- > Senior citizens with QC-IDs in the data list receive the bag of groceries.
- Social pension is for senior citizens who do not receive a pension from any government agency and is through an application verified by the social workers. An ordinance has been introduced to augment the social pension to those not provided by the DSWD.
- > The SSDD is implementing only nutritional food and no sugary drinks for children in the daycare centers while monitoring their weight.

With that, Councilor Lagumbay fully supported the appointment of Ms. Carolina Patalinghog.

Councilor Juico congratulated and supported the approval of the nomination of Ms. Patalinghog, who has been with the Quezon City Government for 42 years. As an employee, she went through the ranks to become a department head of the agency with the biggest scope in serving the constituents and hoping they would have programs and projects helping the less fortunate.

Councilor Bernardo likewise supported the appointment of Ms. Patalinghog and noted that during the SSDD budget hearing, they allocated financial assistance for the fire victims and a budget for food in the evacuation centers. However, he noticed the food they serve for the evacuees is always canned goods like sardines, so he encouraged Ms. Patalinghog to improve and serve nutritional food like vegetables with meat or chicken for evacuees for at least 3-4 days, as SSDD volunteers could help with cooking. He hoped SSDD would consider these suggestions during the budget hearing.

Ms. Patalinghog explained that the evacuation center serves only as a temporary shelter, if they serve regular cooked food like "tinolang manok" or "sinigang," the evacuees might not leave the center. Still, they comply with a healthy procurement to procure vegetables for long-term evacuation.

With no other clarifications, the period of discussion was terminated.

Whereupon, on motion, duly seconded, **PR22CC-1265** was **APPROVED** on second reading, including the councilors present as co-introducers of the measure.

Meanwhile, the Acting Presiding Officer (Councilor Delarmente) yielded the Chair to Councilor Galang-Coseteng.

Councilor Liban (Godie) moved for the approval of PR22CC-1267.

In his sponsorship speech, the Proponent manifested that the resolution pertains to the appointment of Atty. Joselito Vasquez Conejero as City Government Department Head III, Salary Grade, at the Housing Community Development and Resettlement Department (HCDRD) of Quezon City in accordance with the provisions of Section 454, Republic Act No. 7160 of the Local Government Code as stated in the whereas clause.

The Acting Presiding Officer (Councilor Galang-Coseteng) invited Atty. Conejero to address the questions of the members of the City Council.

Councilor Belmonte (Mikey) asked Atty. Conejero for his accomplishments regarding land acquisition while he was an OIC of the HCDRD, to which Atty. Conejero mentioned crafting the Quezon City Local Shelter Plan, "Katiyakan sa Paninirahan" to target 20,000 QCitizens, which they already reached, and continuing to implement the Quezon City Comprehensive Socialized Housing Code.

Councilor Belmonte (Mikey) inquired about Atty. Conejero's immediate plans for 2025, include providing "Katiyakan sa Paninirahan" to 10,000 Informal Settler Families (ISFs). After which, he expressed his support for the measure and endorsed the appointment of Atty. Conejero for his hard work.

Councilor Ferrer likewise manifested her full support for the confirmation of Atty. Conejero.

Councilor Medalla (Aly) mentioned that she began her public service journey with Atty. Conejero, a diligent Legis of then Vice Mayor Joy Belmonte, was well-deserved for his years of work and his passion for the HCDRD team.

Councilor Reyes fully supported his appointment and imparted that he met Atty. Conejero when he was still aspiring to be a lawyer.

Having an ordinance for anti-professional squatting, Councilor Ludovica requested Atty. Conejero for a census of the ISFs, to prevent the increase of professional squatters. He discussed the issue of multiple structures being constructed for rent in Payatas, despite being Conjuanco property. The existing ordinance states that multiple structures owned by an individual that were constructed in a lot owned by someone else were considered professional squatter. With that, he suggested that the Building Official should inspect the building permits of buildings being constructed. After which, he congratulated Atty. Conejero for the confirmation of his appointment.

Councilor Juico expressed his support to Atty. Conejero whom he had known since he was still studying in law school and a staff of then Vice Mayor Ma. Josefina G. Belmonte. Hearing feedback from the urban poor communities, he appreciates Atty. Conejero's transparency and commitment to providing accurate housing information, ensures no relocation and no demolition as long as Mayor Joy Belmonte is present and the community receives what is due them.

Councilor Medina (Candy) congratulated Atty. Conejero on his diligence in implementing the housing program, particularly in District II, and recently the DECA Homes.

Councilor Lagumbay also conveyed his support to Atty. Conejero and hopes to grant housing in District III for Quezon City residents who want to acquire their own house and lot. He recognized the Appointee's efforts to address backlogs and improve QC residents' dignity.

Atty. Conejero thanked the City Council members for the approval and consideration of his confirmation.

There being no further discussions, on motion duly seconded, PR22CC-1267 was **APPROVED** on its second reading, including all the councilors as co-introducers of the measure.

- The qualified beneficiaries are any market vendor, *tiangge* vendor, ambulant vendor, hawker/peddler, or street vendor in Quezon City including their staff, biological and adopted children, or anyone in their custody could apply as a learner to a course offered by the Vendors' Business School;
- The applicant shall submit the following requirements to the MDAD: a notarized affidavit of undertaking signed by the applicant stating that he/she will complete the program or course in which he/she will be enrolled; clearance from MDAD that the applicant is in good standing; and photocopy of applicant's QCitizen ID with the original QCitizen ID presented for verification;
- Initially, the QC VBS is expected to have 124 participants every six (6) months;
- The QC VBS will offer free training programs for the vendor to enhance their business operations and food safety practices, such as bookkeeping, food preservation, and others;

- The QC VBS Technical Committee will manage the formulation and implementation of the school's program; and ensure a holistic approach in its policy implementation and program formulation;
- The partnership will strengthen the effect of local initiatives and ensure that the urban food system is fair, safe, and effective for all their constituents;
- Implementation of this ordinance shall be managed by the Market Development and Administration Department (MDAD), as the lead agency, together with the Small Business and Cooperatives Development Promotions Office (SBCDPO) and the Public Employment Service Office; and
- The necessary funds for this purpose shall be included in the annual General Fund of the Quezon City Government. The MDAD is hereby authorized to allocate the necessary funds for the effective implementation of this ordinance.

Councilor Lagumbay inquired about the needed budget, course term, and partner organization for QC VBS. The Proponent explained that the proposed budget of PhP25,000,000.00 a year is based on the study of the MDAD, and the program will become a regular six-month course training with modules. The MDAD plans to seek external resources, such as NGOs, in the future.

After this, Councilor Lagumbay praised the program for its potential to support small businesses in Quezon City, particularly ambulant vendors, and expressed his support for implementing it as a benchmarking tool for the Quezon City Government.

Likewise, several public consultations were conducted for this purpose recommending that the road lots be donated to the city and a signed master plan be submitted by the petitioner of this rezoning. All the requirements for the rezoning were transmitted to the Committee on City Planning, Building and Zoning.

Further, Councilor Belmonte (Irene) imparted that the ordinance shall be amended, to wit:

- Stipulating the conditions, restrictions, and limitations of the rezoning, such as:
 - o TCT No. N-276400 which is classified as a road lot will be donated to the city, upon compliance with laws for donation;
 - Any new construction or development to be introduced in the area shall adopt the height and density requirement provided in the latest Quezon City Zoning Ordinance;
 - o Shall comply with the latest Green Building Code of Quezon City;
 - The existing open spaces, as included in the submitted master plan, and those created by virtue of this ordinance shall remain their character as an open space and shall not be altered or converted to a buildable state or no building or structure shall be built in this space; and
 - Inclusion of the pedestrian and bike lane shall be introduced and provided in the area where there is no such lane immediately after the approval of this ordinance, subject to the availability of funds of the petitioner of this reclassification;
- A provision for violation and penalties was also included in the ordinance, viz: "The ordinance shall be strictly observed and implemented and violation of any provision of this ordinance shall be subject to the penalties and fines provided for the Quezon City Zoning Ordinance, Green Building Code, and other applicable laws, issuances, and ordinances."; and
- The proposed 19 lots will also be amended to 20 lots because one lot has already been segregated by the property owner.

There being no other clarifications, the discussion was terminated.

Whereupon, on motion, duly seconded, **PO22CC-418** was **APPROVED** on its second reading, adopting the following revisions:

- An amended version of the measure shall be submitted incorporating TCT No. N-276400, a road lot to be donated to the city, particularly Don Antonio Drive, as well as the conditions, restrictions, limitations, violations, and penalties; and
- The title and dispositive portion shall also be amended indicating the specific road lots, as submitted by the City Assessor's Office.

Upon recognition, Councilor Medalla (Ram) moved for the approval of PO22CC-470.

For the discussion, the Proponent highlighted the importance of non-motorized public transportation in the community and the dedication of pedicab drivers. During the Committee on Laws' hearing, many PODA presidents attended and expressed limited earnings, not yet recovering from the pandemic, and not updating on paying fees. For said reason, as Chairperson of the Committee on Transportation, he opted to propose an amnesty for the franchise fees from 2022 to 2025 to ease the burden on unit registration.

There being no other discussants, on motion, duly seconded, **PO22CC-470** was **APPROVED** on its second reading, adopting the amendment to include all councilors present as co-introducers of the measure.
