- It was resolved that this program will be implemented in the entire Quezon City; and

With that, the Presiding Officer clarified Section 7, "Mandates all covered educational institutions to immediately shift into blended learning once there is a cancellation or suspension of classes without any further notice."

The Lady Proponent explained that the amended version, which covers the implementation and activation under Section 6, it follows as per advice of the QC Schools Division Office, that has the power to declare an emergency situation like an extremely hot weather or typhoon.

With that, the Presiding Officer expressed that the measure was really needed.
