According to him, the partial lifting of said moratorium is only allowed upon a systematic study that supports its lifting. For said reason, the City Planning and Development Department (CPDD) and the Committee on Transportation conducted a study using an onboard passenger origin/destination and tricycle mapping survey using an on-board data collection device equipped with sensor and global positioning system capable of recording passenger boarding and alighting times and locations. From said study, the CPDD recommends the maximum required number of tricycle units and route measured capacity needed for the TODA, viz: 62 petitioners from the East Road 20 Congville Bahay Toro TODA (PO22CC-484) and the 17 petitioners from the Sulpicio Francisco St. TODA (PO22CC-485), which are subject to ocular inspection conducted by the Tricycle Regulatory Division of the TTMD.
