IV. CALL TO ORDER

The 2nd Regular Session was called to order at 2:13 P.M. by the Presiding Officer, Vice Mayor Gian G. Sotto.

V. ROLL CALL

VIII. PRIVILEGE HOUR

Signifying his intention to avail of the privilege hour, the Presiding Officer recognized Councilor Alfred Vargas of the 5th District.

Rising on a matter of privilege, Councilor Vargas discussed the urgent issues that the Council needs to address and the task that they need to accomplish in the wake of the recent calamities that befell their beloved Quezon City. He narrated that last week, the entire Metro Manila and other provinces in Luzon experienced massive flooding brought about by the "Habagat" and Typhoon "Crising;" according to DOST-PAGASA, the "Habagat" alone inundated Metro Manila with more than the normal monthly rainfall registered at the Science Garden in just three (3) days, July 19 to 21, 2025; the total rainfall is equivalent to thirty (30) Olympic-size swimming pools or five (5) Araneta Coliseums; and the city's Engineering Department has placed the estimated cost of damages in Quezon City at PhP125 Million. He lamented that, more than the damage to properties and infrastructure, the flooding also carried a human cost. The entire communities were flooded, some are even neck deep; thousands were forced to evacuate; July 25, 2025 had the highest count of evacuees citywide with more than 10,000 families or more than 37,000 individuals sheltered in several evacuation centers; and in fact, the 5th District had the greatest number of displaced residents, with a total of 3,317 families.

The Privilege Speaker stated that responding to the urgent need of rescuing families, working to alleviate the flooding, and providing aid to the evacuees seemed like a daunting task, but the leadership in the entire Quezon City Government rose to the challenge. He then commended Mayor Joy Belmonte for providing steadfast and hands-on leadership during the calamity and providing the firm hand needed to focus on meeting these urgent concerns. He also extended his gratitude and commendation to the brave personnel of the Quezon City Disaster Risk Reduction and Management Office (QCDRRMO) headed by Ms. Bianca Perez. Their timely response, even at the risk of their own lives and safety, should be held as a shining example of selfless dedication to public service, he added.

As the Chairperson of the Committee on Disaster Risk Reduction and as a fellow QCtizen, the good Councilor fully supported the statement and intent of Mayor Joy Belmonte to further upgrade the city's disaster response capabilities and look for long-term and sustainable solutions to the issue of flooding. He proudly announced that because of Mayor Joy's foresight, vision, and singular goal of making Quezon City a model of resilience in the face of climate change, the city already had a Drainage Master Plan, developed in collaboration with the UP Resilience Institute. However, while the local government has already implemented over 120 flood control projects, there is still much work to be done when it comes to national roads within their jurisdiction. He clarified that covered by the Quezon City Drainage Master Plan covers the local and national roads within the city; they had already started fixing the local roads based on the said master plan, but the DPWH still needs to give attention to fix the roads belonging to their mandate.

Continuing further, the Speaker remarked that, as per the City Mayor, the entire plan carries a hefty price tag of PhP27 Billion. It is a necessary burden that they all need to bear, not only Quezon City but the national government as well. For this, he is glad to know that all their Congress Representatives have committed to include the project in the DPWH budget for next year. Again, he commended Mayor Joy Belmonte for bringing together all the Congress Representatives who have the power of the purse and are one with the city government's goal.

Moreover, Councilor Vargas stressed that the Quezon City Drainage Master Plan deserves their total support; it is a long-term solution that should be pursued to completion and should be immune from changes in the political landscape. They have seen how, on the national level, master plans designed to address flooding and other related issues have been poorly implemented or even discarded with the change in national leadership. Since 1952, there have been thirteen (13) major studies and plans for drainage improvement and flood control for Metro Manila conducted with the assistance of international agencies like JAICA, World Bank, and Asian Development Bank. Sadly, despite the comprehensive and long-term nature of said plans, flooding in Metro Manila has gotten worse over the years.

The good Councilor opined that the problem, as it appears, involves execution. As such, he emphasized that continuity for projects that provide long-term relief should be a policy, not a prerogative, citing as an example the desilting of Laguna Lake, which was already approved and funded by the Belgian Government, but was abruptly cancelled, leading to a costly arbitration case where the Philippines was made to pay a hefty settlement. Today, the need to desilt Laguna Lake is being proposed again to address the massive flooding in parts of Metro Manila and Laguna.

As such, the Speaker imparted that floods do not respect political boundaries. While Quezon City is showing the way forward with the drainage master plan, it is incumbent upon the national government to immediately pursue the creation of an updated and comprehensive drainage master plan for the entire NCR to address the perennial flooding in the metropolis; and this regional drainage master plan should be in tune with each of the LGUs' local drainage plans, a requirement where several cities still need to comply with. He informed the Body that, sadly, not all LGUs in Metro Manila have drainage master plans. In fact, Quezon City was one of the first, if not the first, to have such an updated master plan.

Relaying that such a drainage master plan needs to be implemented with greater urgency, Councilor Vargas is certain that the City Council will extend the necessary budgetary support and oversight until the goal is achieved. However, there are related concerns that need to be addressed. He pointed out that while cleaning and upgrading of drainage system are important, the support of the people to proper garbage disposal is likewise important. He then cited as an example the bridge (used by the people from North Fairview going to Sta. Lucia) that collapsed during the said storm due to the volume of garbage thrown therein. He then called for discipline in the disposal of garbage and other waste materials. Tons of garbage collected after the "Habagat" served to aggravate the flooding and presented challenges to the personnel tasked with clearing the roads and alleyways, he lamented.

In addition, Councilor Vargas mentioned that another concern is the need for more permanent evacuation centers for the city; the reality they are facing now is that climate change is the new normal; and the risks to the lives and safety of their constituents have increased. As the author in the House of Representatives of a proposed legislation to build permanent evacuation sites in all localities, he urged his colleagues to provide the needed budgetary allocation to immediately build more inclusive, accessible, and technologically capable evacuation centers.

For Councilor Vargas, they need to have more conversations with the people on the issue of climate change, and how their actions and behavior will have both positive and negative impacts on the city. It is not only the job of the city officials; the private sectors, NGOs, civil society organizations, and every QCtizens should all be one in this matter. They need to know regularly their needs and concerns, especially during calamities and after, when those affected start to rebuild their homes and their lives. These include more people-participation mechanisms and more training and capacity-building efforts for the QCitizens.

As the Chairperson of the Committee on Disaster Risk Reduction, Councilor Vargas saw the importance of further strengthening the DRRMO. For him, they need to extend all the needed support in terms of manpower, equipment, training, and new technology to efficiently respond to their constituents' needs. For this reason, his representation will file an ordinance converting the Disaster Risk Reduction Management Office into the Disaster Risk Reduction Management that disaster response and management are a top priority of the Quezon City government.

To conclude, Councilor Vargas stated that resilience and governance are two faces of the same coin; a locality can never be truly resilient unless there is good governance, and good governance always strives to promote resilience. The people of Quezon City, he said, are fortunate to have a proactive and visionary leadership in the person of Mayor Joy Belmonte; the City Council, on the other hand, is equally honored to have such leadership in the person of Vice Mayor Gian Sotto. It is up to them, members of the City Council, to guarantee that they move beyond the quick fixes, knee-jerk or band aid solutions to calamities, and work together with the Executive, the private sector, and the people of Quezon City in pursuing long-term, relevant and doable solutions to secure the future not just for Quezon City, but the whole country. "When we work together, we win together," he uttered.

For the interpellation, Councilor Suntay manifested his support for the upcoming proposed measure of Councilor Vargas. As Chairperson of the Committee on Information Technology, he believes that disaster risk and information go hand in hand; they would be able to mitigate and act faster when they have good information and technology to respond to the needs of their constituents.

Upon recognition, the Majority Floor Leader first thanked Councilor Vargas for delivering his very relevant speech. They had all witnessed how the "Habagat" and the three (3) typhoons almost flooded the entire city. For her, the proposals of the good Speaker are actionable; the DRRMO, which is currently under the Office of the City Mayor, deserves more support and manpower to respond; not just the said office, but the rest of the city to capacitate everyone to be able to respond to these kinds of calamities. She also thanked Councilor Vargas for willingly sponsoring the state of calamity declaration during the pandemic and the rest of the City Council for the 100% attendance during said time. She reiterated their full support for the initiatives of the Chairperson of the Committee on Disaster Risk Reduction and encouraged all the councilors to actively participate in the hearings, once scheduled.

Likewise, the Presiding Officer expressed gratitude to Councilor Vargas for pouring out his heart on this matter. Aside from strengthening the programs and upgrading the drainage system, His Honor enjoined everyone to consider environmental education and awareness programs. In the DRRMO presentation, during their meeting, it was found out that improper garbage disposal is one of the primary problems, and in another presentation, it was shown that those areas, after being cleared of garbage, do not flood anymore even in heavy rains, which goes to show that the city has a drainage system that works. As such, Vice Mayor Sotto reiterated to include and level up environmental education and awareness, as well as proper garbage disposal in the community, along with the updating of the drainage plan to mitigate floods in the city.

Councilor Bernardo attested to the massive effect of the flood on everyone, especially on the students. He expressed full support to the Speaker's proposal of converting the DRRMO into a department, which has more budget and manpower to respond to its constituents. He also thanked Councilor Vargas for making him the Vice Chairperson of the Committee on Disaster Risk Reduction.

Before terminating the privilege hour, Councilor Vargas invited his fellow councilors to be members of his committee. He believed that, aside from hard work, teamwork would make the committee better at finding sustainable solutions.

There being no other manifestations, the privilege hour was terminated.
