All members of the 22<sup>nd</sup> City Council were physically present except for Councilor Belmonte (Mikey) who attended virtually.

There being a quorum, the Body proceeded with the day's business.

#### VIII. PRIVILEGE HOUR

Upon recognition, Councilor Ludovica proceeded to his privilege speech, quoted as follows:

"Marami pong salamat, Ginoong Tagapangasiwa, at sa mga kasamahan ko ho na mga lingkod bayan, isang mapagpalang Lunes ng hapon po sa ating lahat.

Ang paggamit ko po ng Karapatang Pagpapahayag ay ito po ay naaayon sa mga kasalukuyang nangyayari po sa ating lungsod. Ang pamagat po nito: 'MMDA, anong nangyari?'

Ang MMDA po ay ito ho ay krineeyt (create) ng isang Republic Act, Republic Act 7924, para ho pagkaisahin ang labing-pito at isang munisipyo na tinatawag po na Metro Manila o mga karatig po sa ating lungsod.

Ang Quezon City ho, nakikita ho natin ngayon sa atin pong mapa na atin pong pinakikita na ang gaano ho kalaki ang ating lungsod, pinakamalaki sa mga bayan at lungsod na nasasakupan ho ng MMDA. Ang ating lungsod ay merong 161.11 kilometers, square kilometers o 62.20 square miles. At ang ating lungsod din ho ang may pinakamaraming kalsada. Meron ho tayong 2,439.31 kilometers road at eighty (80%) percent ng kalsada po natin, ang ating lungsod ang nagme-maintain. Thirteen (13%) percent lang ang mini-mentina ng atin pong national government.

Ano-ano ba ng function ng MMDA? Ayan po, base ho sa rules, sa Implementing Rules and Regulation nila, oho, ang MMDA po, ang kanila pong scope of services and authority, iyan po ay kino-comprise ng buong miyembro ng ating lungsod, ng ating Metro Manila. At ang primary, hindi ko na ho iisa-isahin dahil marami ho ito, ang pinaka-dalawang importante na kailangan ng ating lungsod, ang serbisyo ng MMDA – iyan po ang transport at traffic management. Nand'yan po, nakatala, nakasaad ang kanila pong function, na magkaroon ng kaayusan ang daloy ng mga trapiko ng ating mga lansangan.

At dito rin ho, nakasaad sa kanila hong function ang public safety. Alam naman po natin ngayon na ang kadalasan ho na sanhi ng aksidente, hindi lang ho sa ating lungsod o sa iba't-ibang parte na nasasakupan ng MMDA, ay 'yung aksidente na ang sanhi ho ang kanilang mga road o cement barriers po nila. Bakit nagiging sanhi ang mga barriers na ito ng aksidente? Dahil ho sa mga kakulangan ng mga safety measures. Sabi nga ng mga driver na naaksidente, nabubulaga sila dahil walang reflectorized karamihan sa mga concrete barriers natin. At ang mga barriers na 'to ay kumitil ng mga buhay at ari-arian ng mga pribadong sasakyan.

Marumi, hindi nalilinisan. Kasama rin ho ang ating lungsod po d'yan, ho, kasama rin ho ang DPOS, ang ating lungsod, na marami rin ho tayong plastic barriers na hindi rin ho name-maintain. Nasaan na ang beautification? Nasaan na ang public safety? Sa gabi, ayan po, nakikita n'yo, talaga naman ho, kung kayo ay motorista, mapapailing na lang ho kayo sa nakikita po natin.

Kahit anong gawin ng ating lungsod sa pagpapaganda ng ating mga kalsada, hindi ho kaaya-aya tignan dahil sa mga barriers pong ito. Hindi lang ho naglalagay sa ka ... kapanganiban ng ating mamamayan, kung hindi, nagiging eyesore pa sa paningin ng tao.

Alam din po natin, lalong-lalo na ho ang aming pinanggagalingan ng kapwa ko senior citizen na si Godofredo Liban, na taga-Lagro, dumadaan ho kami sa Commonwealth, sa Commonwealth ho, napakasikip na ng trapiko.

Nasaan ang common sense ng mga taga-MMDA at DPWH na during rush hour, alassiete ng umaga, nagre-repair ng kalsada? Kung nabibili lang, gagawing ayuda ang common sense, bibigyan ko ng maraming ayudang common sense ang mga taga-MMDA at DPWH.

'Yung solid waste disposal po natin, 'yan ho ang iha-highlight ko lang sa inyo. Pero gusto ko ho munang malaman ninyo, ano ba ang kontribusyon ng Lungsod Quezon sa pag-o-operate sa financial o sa pondo ng MMDA? Five percent (5%) ho ng ating gross income, revenue income ha, five percent (5%) ng gross revenue income monthly ay atin pong nire-remit para sa pondo ng MMDA. Habang nangongolekta tayo, napapataas natin ang taxes natin, lumalaki ang remittance, ang kontribusyon ng Lungsod Quezon sa MMDA. Worth kaya ang binibigay natin?

Last year, almost PhP1Billion plus ang kontribusyon ng Lungsod Quezon. Alam naman ho natin na may climate change, isang dekada na, mahigit isang dekada na, alam natin may climate change. Ang pagbaha sa konting ulan, kawawa ang mga taga-District 1 hanggang Talayan at District 4 dahil binabaha.

Nasaan na? Ano na ang proyekto n'yo sa mga kalsada at ilog natin?

Ang San Juan River na tinatawag, 'yan ho ang isa sa dahilan kung bakit mula sa may Pasong Tamo, Culiat hanggang sa boundary natin ng Maynila ay binabaha tayo dahil 'yang ilog pong 'yan, 'yan po ang dinadaanan ng napakadaming tubig na hindi na kinakaya.

Tanong lang po natin, ano na ho ang plano ninyo?

Bagong gawa ang Timog, Morato, pero nu'ng umulan, kita n'yo ho sa screen. Alam naman po natin na ang MMDA ho ang siyang nangangasiwa sa mga problema natin dito. Kahit DPWH, ang nagpapa-implement, karamihan may implement ang DPWH pero meron din ho ang MMDA.

Sa kabatiran po ninyong lahat, ang Lungsod Quezon ay nag-donate ho tayo ng dredging machine para sana magamit para mabawasan ang pagbaha ng ating lungsod.

Tatanggapin na lang ba ho natin? 'Wala tayong magagawa, climate change na, eh.' Pero, nakalimutan ho nila, na noon pa man pinagagawa na ho tayo nila ng adaptation, resiliency, mitigation plan. Ano na ang mitigation plan ninyo para matapos naman ang pagdurusa ng mga taga Quezon City?

Sa akin hong mga kasamahan sa pulong na 'to, ang inyong abang-lingkod po nagtatanong lang – hahayaan na lang ba natin na magdusa ang mga taga-Quezon City? Hahayaan na lang ba natin na sila na lang lagi ang nagpaplano, nagdidisenyo sa mga problemang tayo ang nagsasakripisyo?

Kaya, Ginoong Tagapangasiwa, ako po ay tumatayo sa bulwagang ito at hihingiin ko ho ang kapahintulutan ng saping ito, na sana ho, in aid of legislation, baka pwede naman ho nating ipatawag, tanungin ang mga nasa ahensya po na ito para malaman natin kung ano ang plano po nila. Kung ano ang adaptation plan nila sa San Juan River. At ano ang kanilang aksyon doon sa mga barriers na nagiging sanhi pa ng aksidente.

Kaya umaapila po ako sa Council na ito, in aid of legislation, para naman makatulong tayo sa pagbigay ng solusyon, na minumungkahi po ng inyong abang-lingkod, patawag ang mga ahensiya ng Laguna Lake Development Authority, MMDA, DPWH, Quezon City Engineering, Quezon City Task Force Traffic, Transport Management, para magkaroon ho tayo ng konkretong solusyon dahil alam ko po, ang mga konsehal na nandito ay may kanya-kanya rin hong karapatan na magpahayag kung ano ang nararapat gawin sa kanilang mga distrito. At binubukas ko na rin po, na ang sino man ho na gustong magtanong, o magpahayag din tungkol po sa karapatan pong ito, nakalaan ho akong tumugon sa kanilang katanungan, Ginoong Tagapangasiwa."

In the period of interpellation, Councilor Vargas expressed his full support to the privilege speech of Councilor Ludovica. He added that the Metropolitan Manila Development Authority (MMDA) was established as a political administrative body. He said that he agreed to what they have seen on screen that whatever the LGUs could not run will be managed by the MMDA like the issue of flood in Metro Manila. He stressed that the flood does not select any LGU. It does not mean that a certain city could not be affected by flood if they are located in the boundary of the Cities of Caloocan and Manila. He recalled that as a former Congressman, he always defended the budget of the MMDA and they have a specific budget for the flood control and distributed equally according to districts. With that, he moved that when this matter will be referred to the respective committees, he suggested that the distribution of budget on flood control in Metro Manila is based on flood-prone areas and will be the one to get the lion's share of the budget. He also stated that he will attend the hearing on this matter in aid of legislation.

In relation to the series of queries of Councilor Lagumbay, Councilor Ludovica answered that all cities in Metro Manila are contributing a mandatory 5% from their gross revenue. He informed that in the last budget, Quezon City had remitted more than PhP1 Billion. He added that earlier, he emphasized that Quezon City has 2,439.31 km roads, 83% of which are maintained by the city and only 13% are being maintained by the national government. He said that the said amount is already sufficient to the needs of the Quezon City Government if the latter will be the one to manage said amount for the roads of Quezon City. He also set as an example that 80% of the roads of Quezon City are being maintained by the local traffic enforcers.

With that, Councilor Lagumbay stressed that he wanted to be clarified from the MMDA as to the number of detailed/assigned personnel/traffic enforcers to the problematic roads. He added that the biggest problem of Districts I, II, V, and VI is the truck ban. With that, he requested if they could invite the concerned agency to know their plans on this matter.

At this point, Councilor Lagumbay suggested to the Speaker to encourage the MMDA to give them the breakdown of where the said PhP1 Billion was spent because the city government should also know if such amount was properly allocated to appropriate concerns in the city. As the Speaker mentioned, there are problems with the barriers, which are not reflectorized. Gladly, he stated that bike lanes in Quezon City are reflectorized, which is very good. Also, there are flood-prone areas in different districts of Quezon City that should be given attention, especially during the rainy season. He learned that the dredging machines that were donated to the city are not suitable for the small creeks and rivers in Quezon City. Thus, he encouraged the MMDA to enable the city to use its machines to dredge those clogged riverways and canals in the city. In addition, Councilor Lagumbay observed that there are no lights along C-5, which is a national highway, resulting in accidents in the area.

Concurring thereto, Councilor Ludovica cited as an example the Skyway wherein all the concrete barriers are clean and reflectorized. Why does the private could do it while the government could not do it even if it has a much higher project cost, he asked. He also observed that almost all national roads in the city have the same problem just like the asphalt overlaying, which is easily washout out.

With that, Councilor Lagumbay expressed his hope that the good Speaker would have a good dialogue with the MMDA relating to the foregoing concerns.

In answer to the query of Councilor Galang-Coseteng, concerning the linkage between DPWH and MMDA regarding the project execution and implementation, Councilor Ludovica replied in the affirmative.

After which, Councilor Galang-Coseteng reiterated the same sentiments regarding the asphalt overlaying on the roads which are easily washed out. In aid of legislation, she suggested including representatives from DPWH in the dialogue and asked why they are not using cement, which is a more durable road with a minimal difference in cost.

Similarly, Councilor Juico imparted that he has also some queries to the MMDA, such as, how they are utilizing the funds contributed by the Quezon City Government and the other Local Governments Units in Metro Manila, the Non-Contact Apprehension Program (NCAP), the towing services, which should be accredited by the MMDA, the flood control program and others. To his knowledge, said funds should be allotted by the MMDA for the implementation of plans and programs for the entire Metro Manila only; if the said funds are being utilized for the operation and maintenance of their office, then it is not within the mandate of the given fund. As such, he hoped that the Speaker could schedule a meeting with the MMDA so they could clarify things and be enlightened.

Councilor De Leon manifested his full support to Councilor Ludovica. He just requested to include as one of the priority areas of concern the traffic situation on certain MMDA roads. He read that the mandate of the MMDA is to harmonize all the cities in Metro Manila into either one traffic system, one service system, and one transportation system. However, the same was not explained to them just like the U-turn slots in Katipunan, which are being designated suddenly without proper coordination with the Department of Public Order and Safety (DPOS), and the respective barangay or city government.

Councilor Malañgen likewise conveyed her support to Councilor Ludovica. She manifested that it is very timely to enlighten this issue, especially because their barangay is one of the most affected by floods during the rainy season for decades already. She also raised her concern about the truck ban because several heavy trucks are constantly parked along Araneta Avenue. She also wanted to be clarified on the yearly repairs of the streets due to different reasons that affect the public and are a waste of funds. For said reason, she requested to be allowed to attend such dialogue/meetings with the concerned agencies.

Expressing his support, Councilor Medalla (Ram) requested that he also be included in the meeting to be conducted as Chairperson of the Committee on Transportation.

With that, Councilor Ludovica suggested making this Council a committee as a whole to enable all the councilors to ask and input their concerns for the betterment of their districts.

As for the Presiding Officer, the privilege speech is very important for all of them to be informed. It is also a blessing that Mayor Ma. Josefina G. Belmonte is one of the members of the MMDA Council, hence Her Honor could guide the City Council in conducting a consultative meeting-dialogue with all the concerned agencies to discuss their programs and be clarified on where the said PhP1 Billion are being spent, the same with the redundant road repairs done always. As an advocate of Good Governance and Transparency, those concerned agencies could also be transparent with them, he stressed.

The Presiding Officer remarked that they could conduct a joint committee hearing and invite the DPOS, MMDA, and DPWH so that they could all be on the same page.

Relative thereto, Councilor Ludovica moved to conduct a committee of the whole and note it immediately, to which the Presiding Officer acceded.

With that, the motion of Councilor Ludovica was APPROVED

Likewise, Councilor Belmonte (Irene) moved that if the foregoing privilege speech Councilor Ludovica will be conducted as a committee as a whole, make the Speaker the Chairman, and co-chaired by the Majority Floor Leader.

The foregoing motion was, likewise, adopted.

At this point, as moved by the Majority Floor Leader, the foregoing speech was **REFERRED** to the Committees on Public Order (main committee), Infrastructure, and Disaster Risk Reduction.

At this juncture, the Privilege Hour was terminated.
